Frequently Asked Questions

1. **Q:** What is a CAGE code?

A: The Commercial and Government Entity Code, (CAGE Code) is a unique identifier (like factory ID) assigned to a supplier by various governments or defense agencies. CAGE codes provide a standardized method of identifying of a given facility at a specific location.

2. **Q:** What products (part numbers) are affected by CAGE code change?

A: Since a CAGE code is a “factory ID” it is not limited to any specific part number but to all products where CAGE code identification is required.

3. **Q:** Is there any impact on form, fit and function on VPG parts due to this change?

A: There is no impact on form, fit and function of the supplied products.

4. **Q:** Is there any change in packing and labelling due to this change?

A: The newly assigned CAGE code will replace the previous one where CAGE code identification is required by product specifications.

5. **Q:** Is there any change in specific product part number or/and ordering information due to this change?

A: There is no change in product part numbers or/and ordering information.

6. **Q:** Is this notification relevant to me (a specific customer)?

A: Yes, providing you purchase products which require CAGE code identification (marking, labelling).
