Product data sheet

1. General description

The 74LV08-Q100 is a quad 2-input AND gate. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess V_{CC} .

This product has been qualified to the Automotive Electronics Council (AEC) standard Q100 (Grade 1) and is suitable for use in automotive applications.

2. Features and benefits

- Automotive product qualification in accordance with AEC-Q100 (Grade 1)
 - Specified from -40 °C to $+85\text{ °C}$ and from -40 °C to $+125\text{ °C}$
- Wide supply voltage range from 1.0 to 5.5 V
- CMOS low power dissipation
- Latch-up performance exceeds 100 mA per JESD 78 Class II Level B
- Optimized for low voltage applications: 1.0 V to 3.6 V
- Accepts TTL input levels between $V_{CC} = 2.7\text{ V}$ and $V_{CC} = 3.6\text{ V}$
- Typical output ground bounce $< 0.8\text{ V}$ at $V_{CC} = 3.3\text{ V}$ and $T_{amb} = 25\text{ °C}$

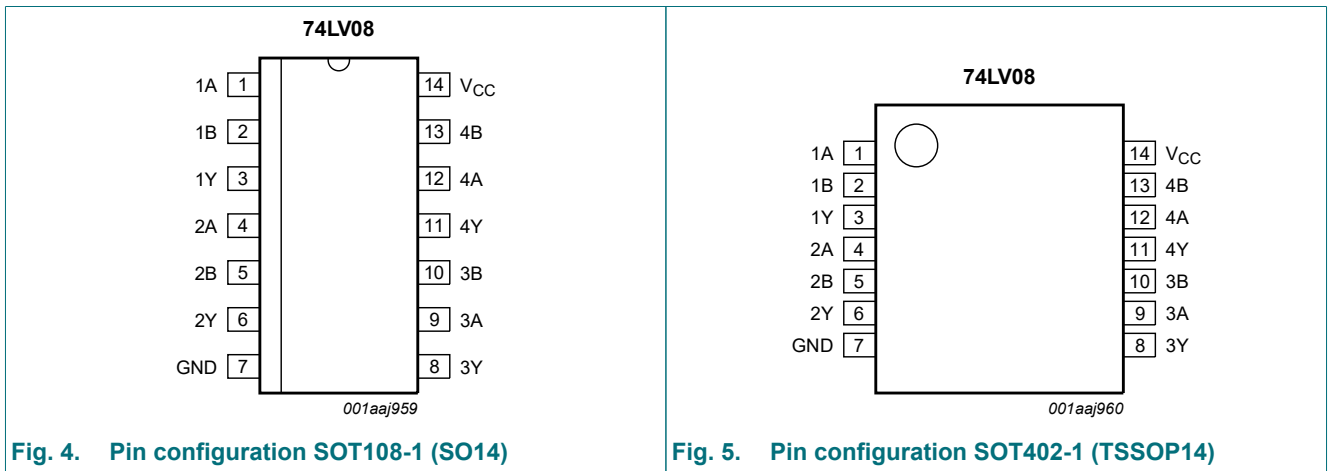

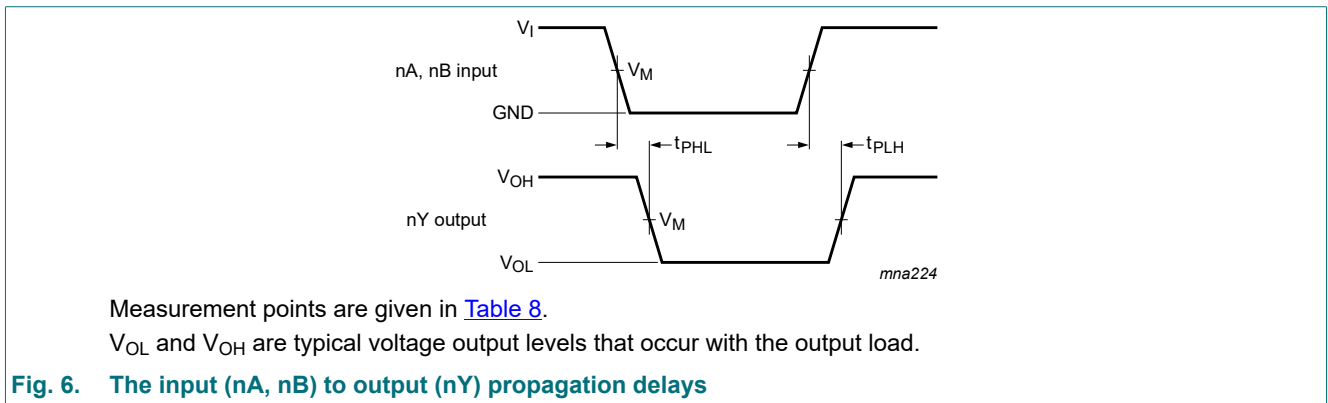
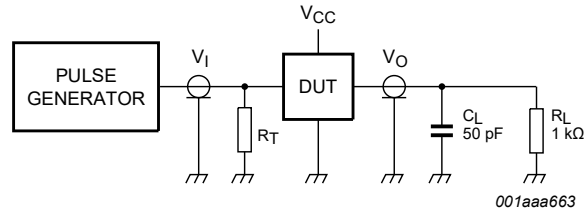
