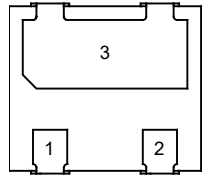
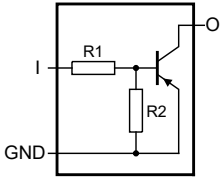

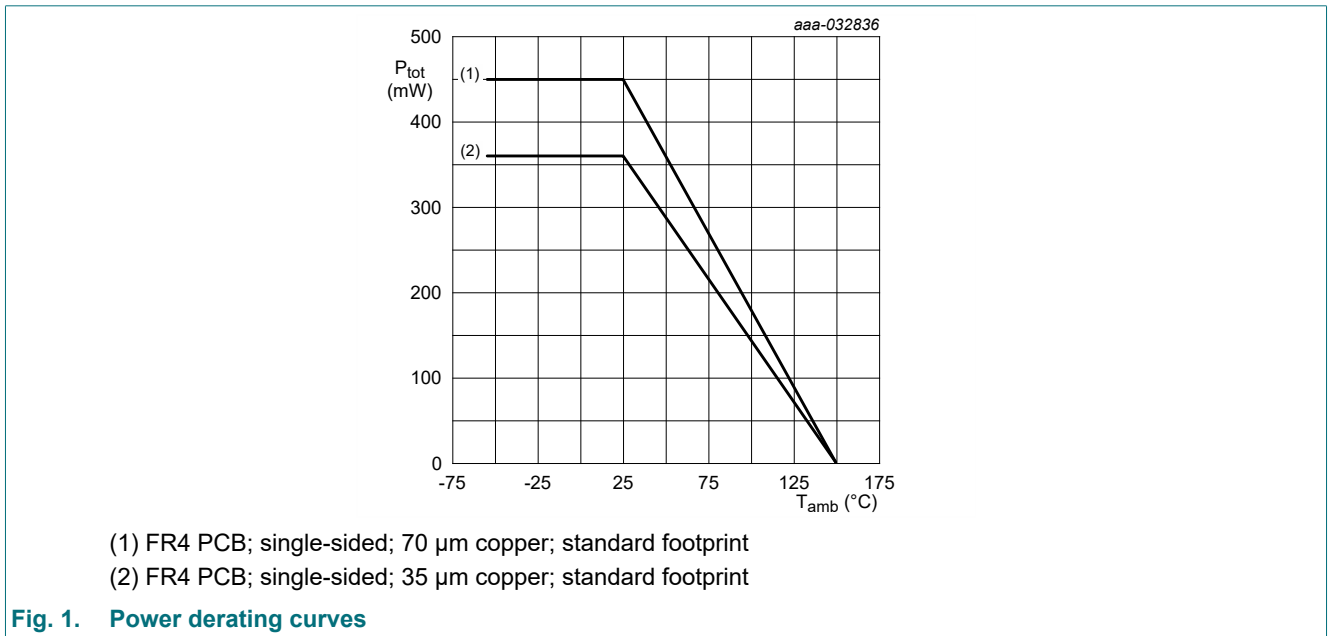


Fig. 1. Power derating curves

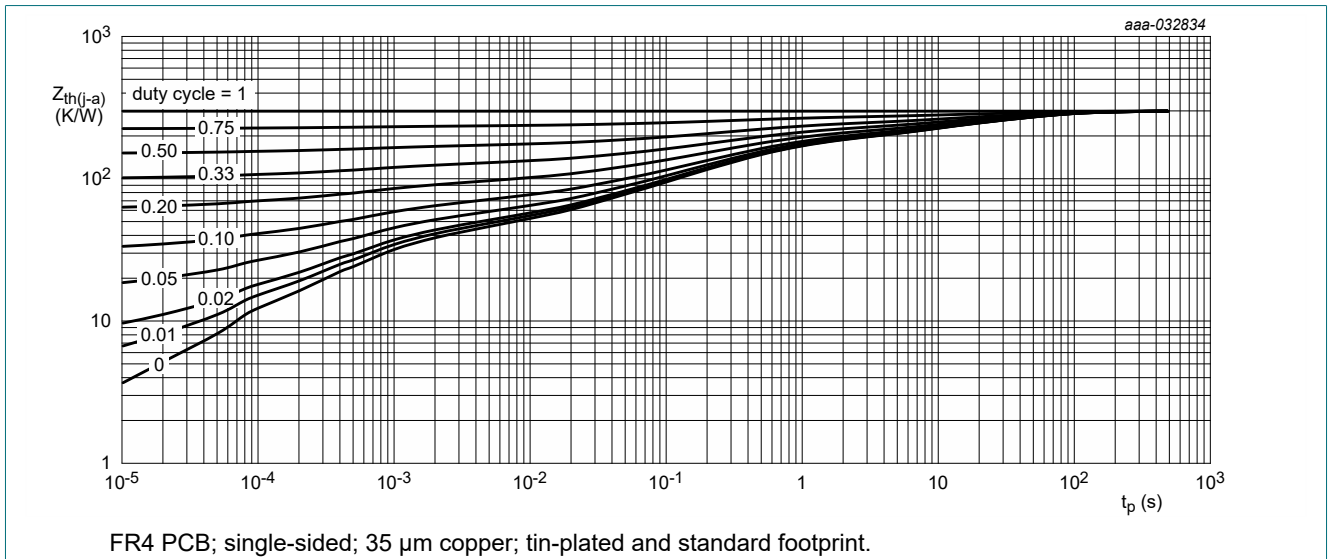


Fig. 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

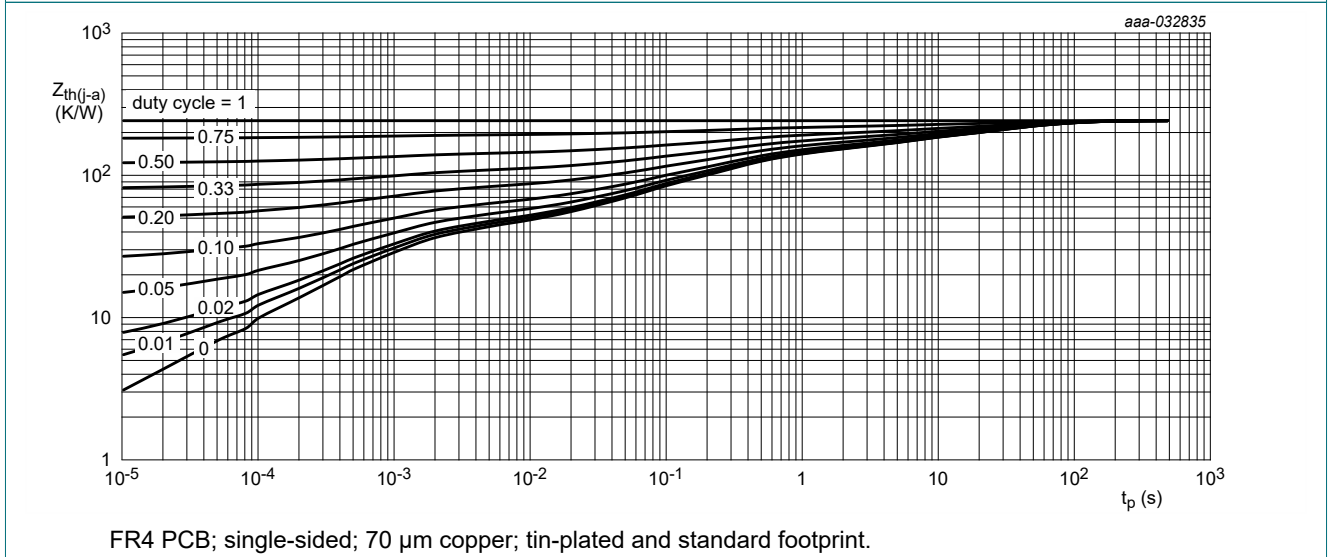


Fig. 3. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

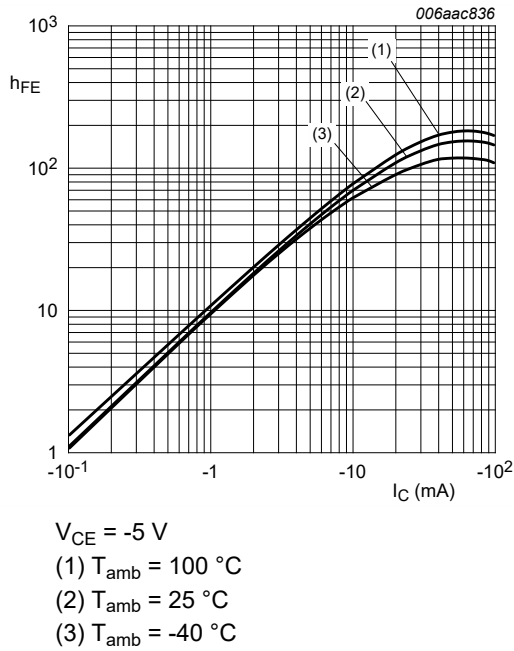


Fig. 4. PDTA143EQC: DC current gain as a function of collector current; typical values

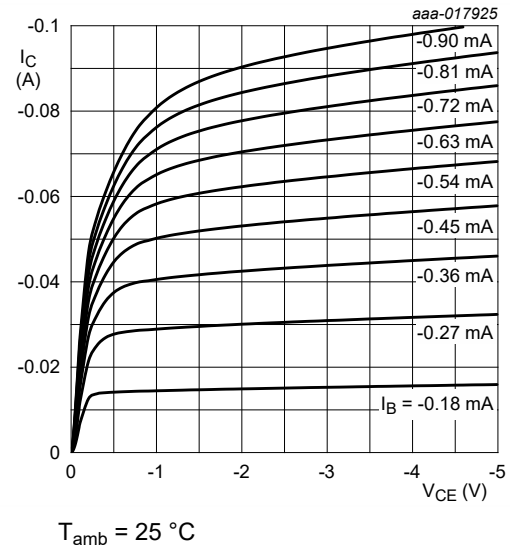


Fig. 5. PDTA143EQC: Collector current as a function of collector-emitter voltage; typical values

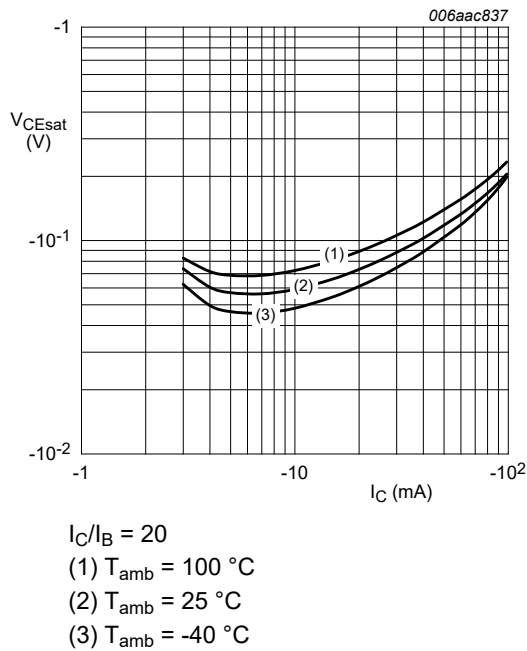


Fig. 6. PDTA143EQC: Collector-emitter saturation voltage as a function of collector current; typical values

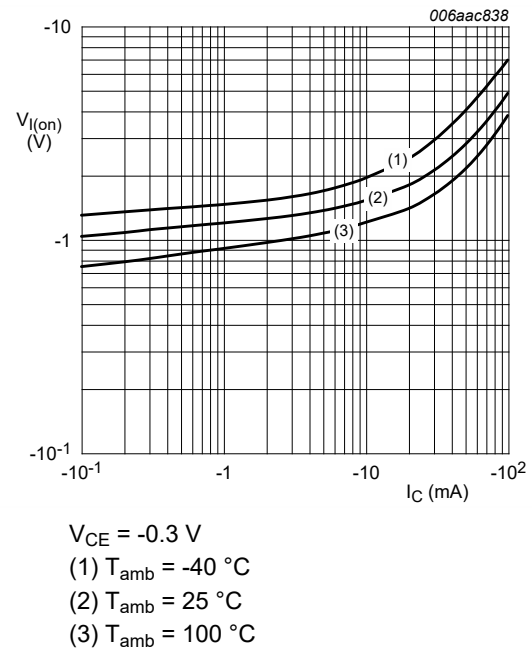
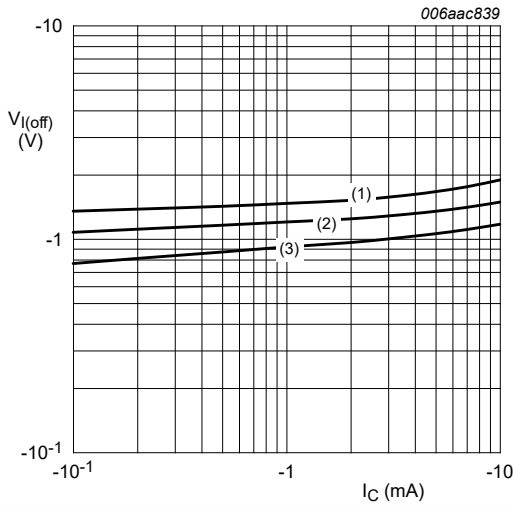
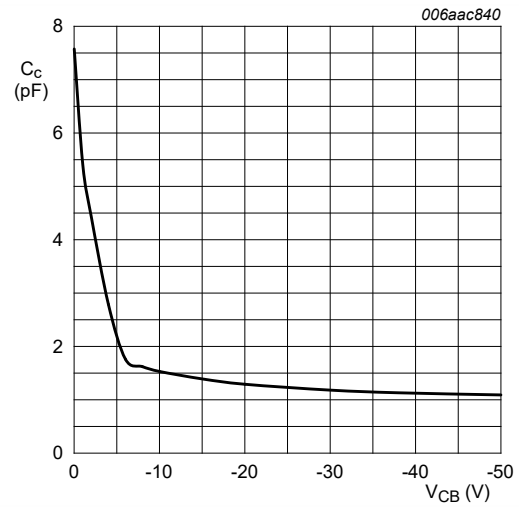


Fig. 7. PDTA143EQC: On-state input voltage as a function of collector current; typical values



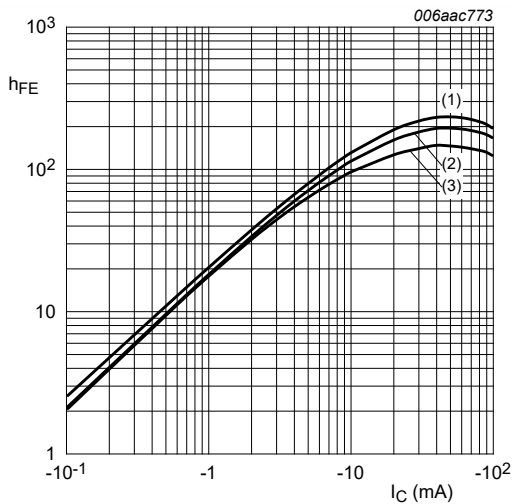

Fig. 8. PDTA143EQC: Off-state input voltage as a function of collector current; typical values



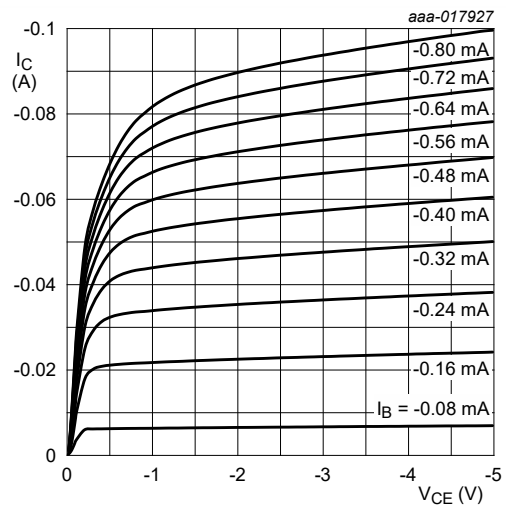

Fig. 9. PDTA143EQC: Collector capacitance as a function of collector-base voltage; typical values



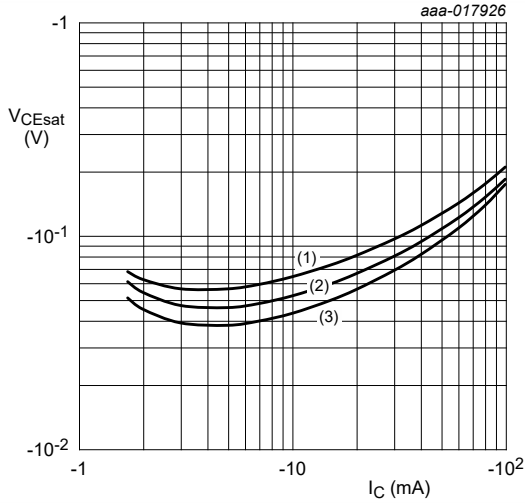

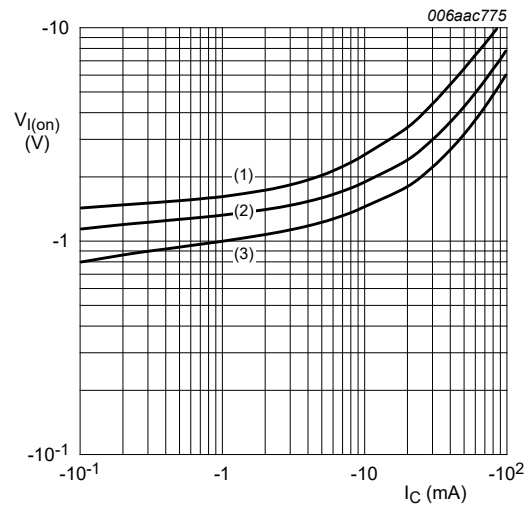
Fig. 11. PDTA114EQC: Collector current as a function of collector-emitter voltage; typical values

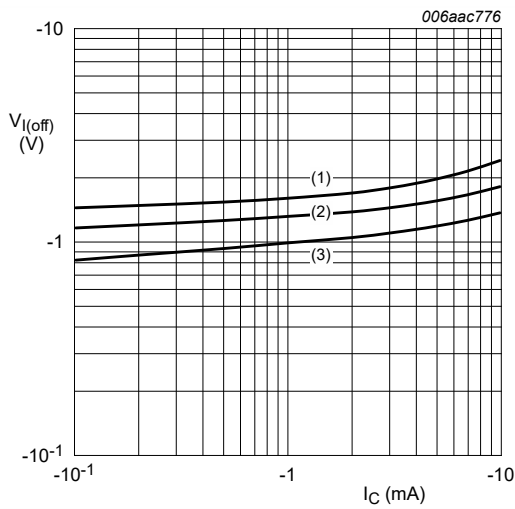
Fig. 12. PDTA114EQC: Collector-emitter saturation voltage as a function of collector current; typical values

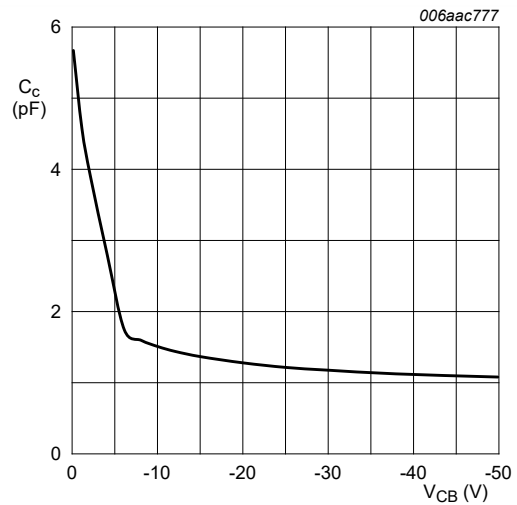
Fig. 13. PDTA114EQC: On-state input voltage as a function of collector current; typical values

Fig. 15. PDTA114EQC: Collector capacitance as a function of collector-base voltage; typical values

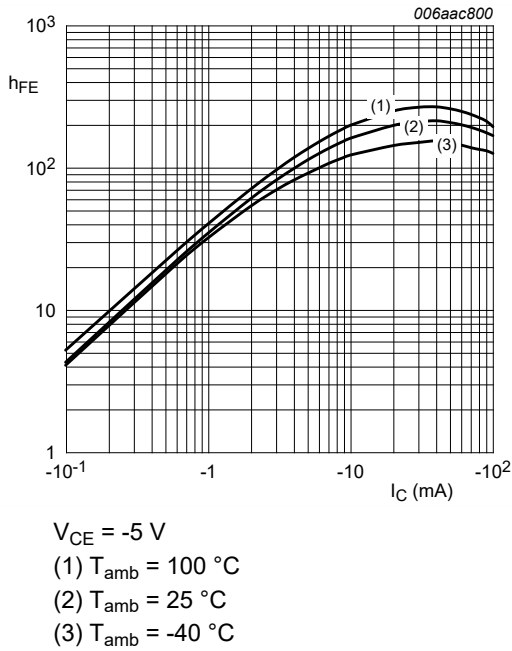


Fig. 16. PDTA124EQC: DC current gain as a function of collector current; typical values

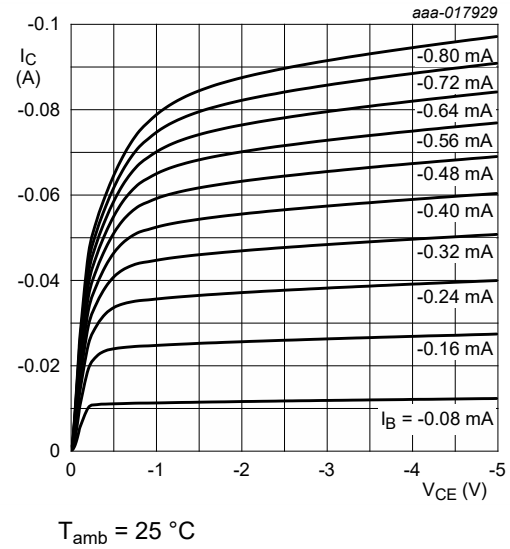


Fig. 17. PDTA124EQC: Collector current as a function of collector-emitter voltage; typical values

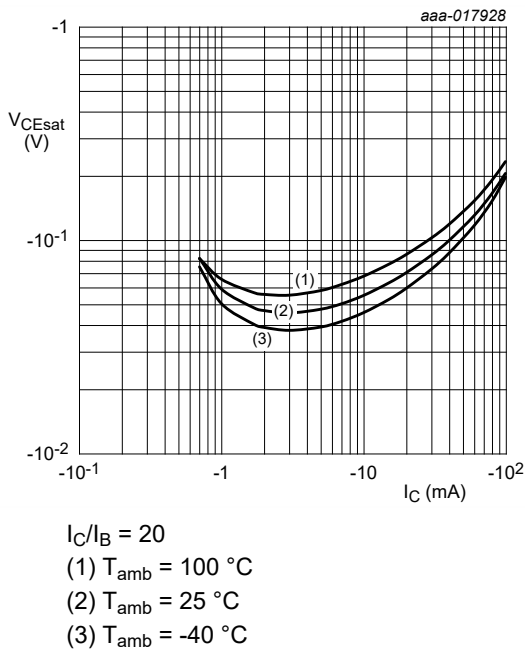


Fig. 18. PDTA124EQC: Collector-emitter saturation voltage as a function of collector current; typical values

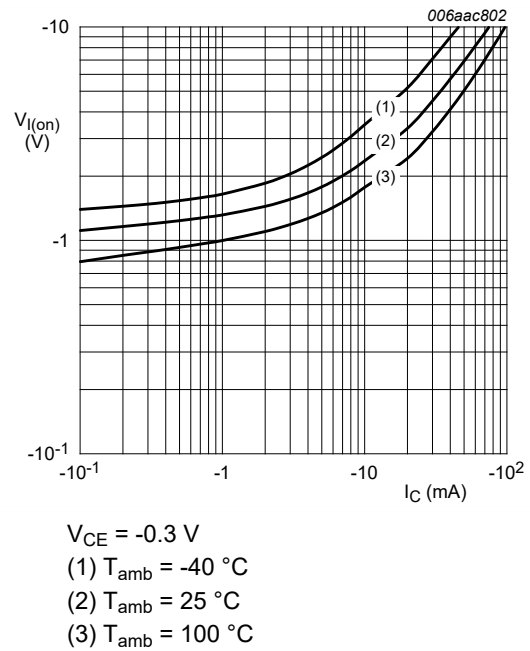
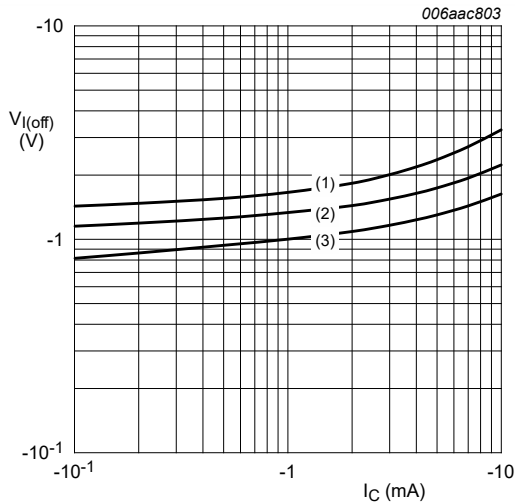


Fig. 19. PDTA124EQC: On-state input voltage as a function of collector current; typical values



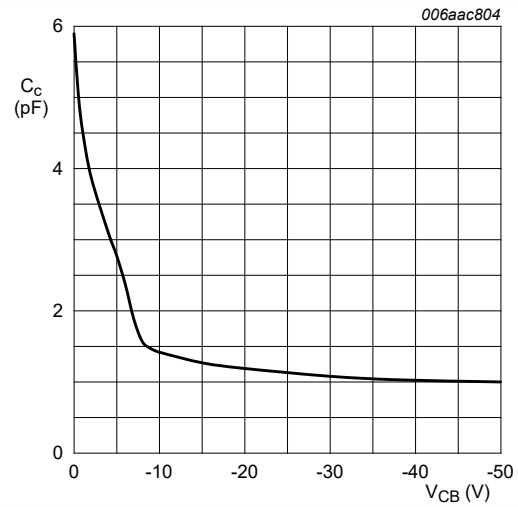

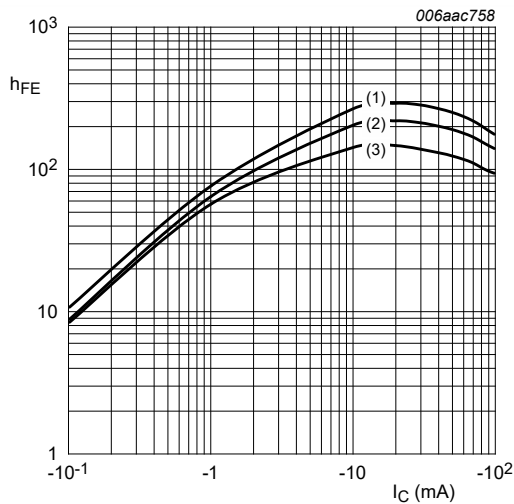
Fig. 20. PDTA124EQC: Off-state input voltage as a function of collector current; typical values

Fig. 21. PDTA124EQC: Collector capacitance as a function of collector-base voltage; typical values



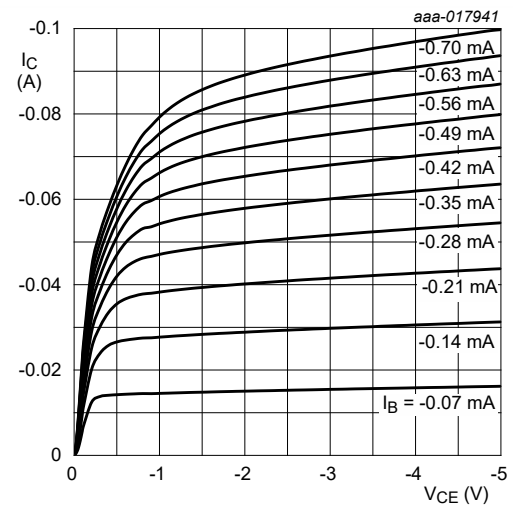

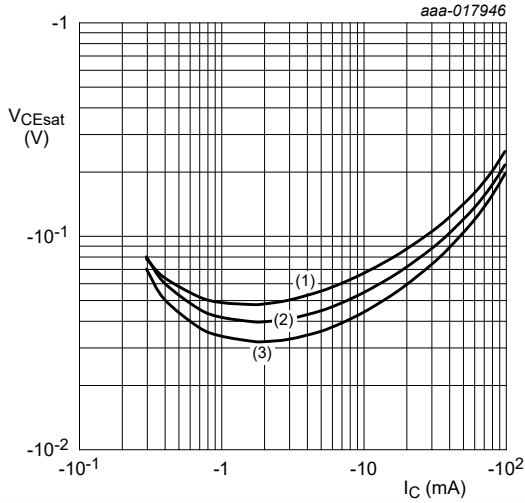

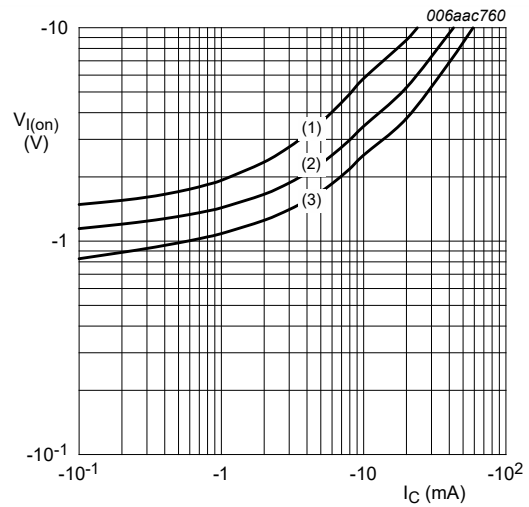
Fig. 23. PDTA144EQC: Collector current as a function of collector-emitter voltage; typical values

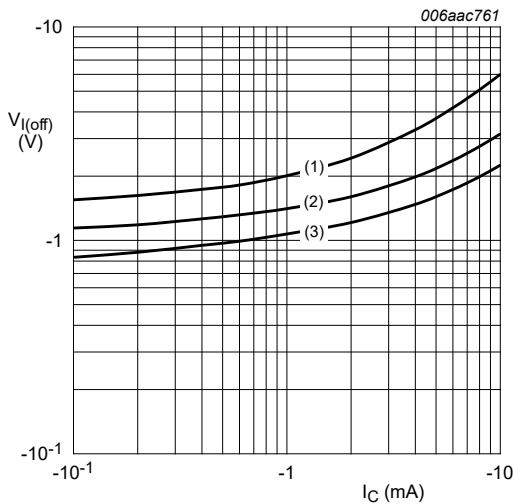
Fig. 24. PDTA144EQC: Collector-emitter saturation voltage as a function of collector current; typical values

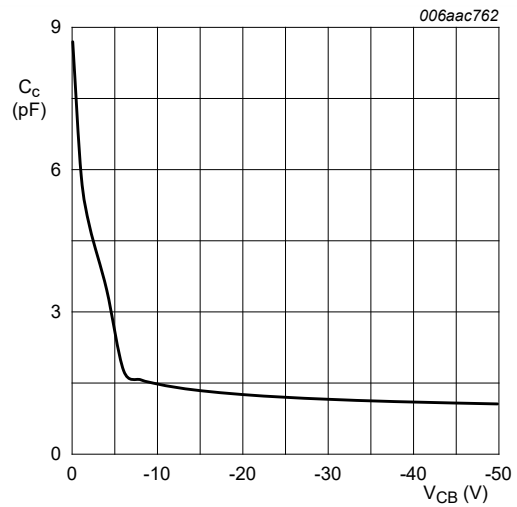
Fig. 25. PDTA144EQC: On-state input voltage as a function of collector current; typical values

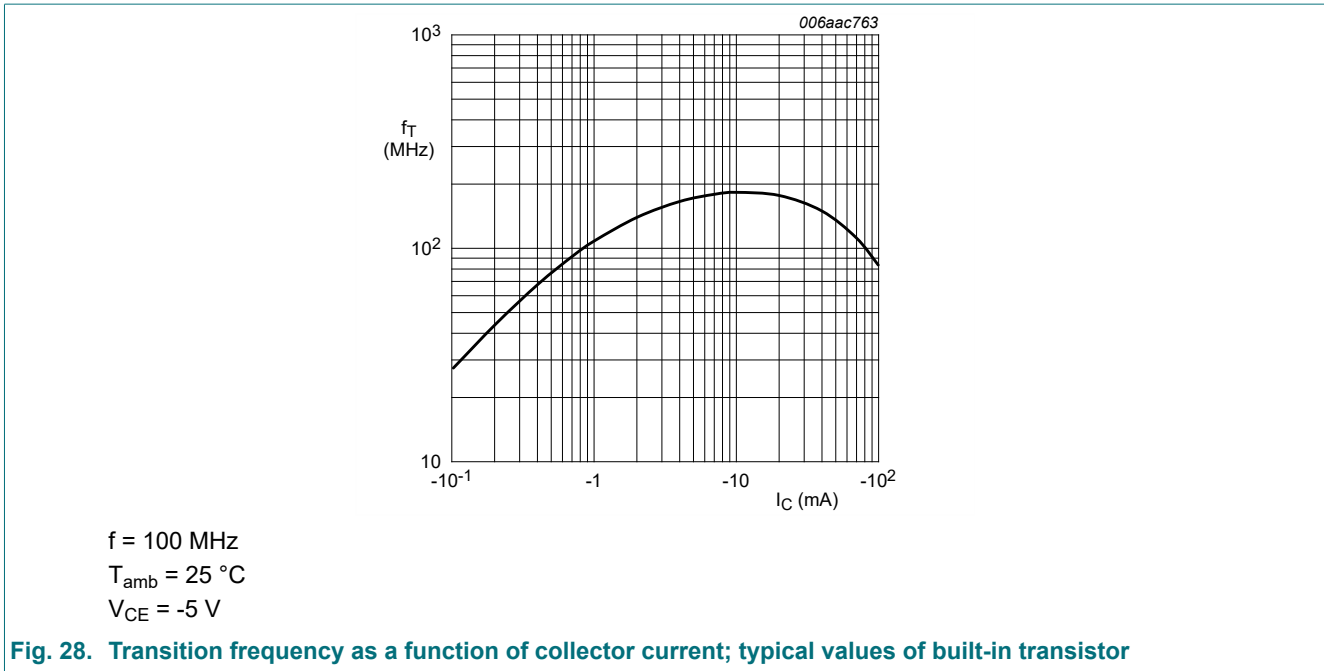
Fig. 26. PDTA144EQC: Off-state input voltage as a function of collector current; typical values

$$\frac{R2}{R1} = \frac{V(I14) - V(I13)}{R1 \cdot (I14 - I13)} - 1$$

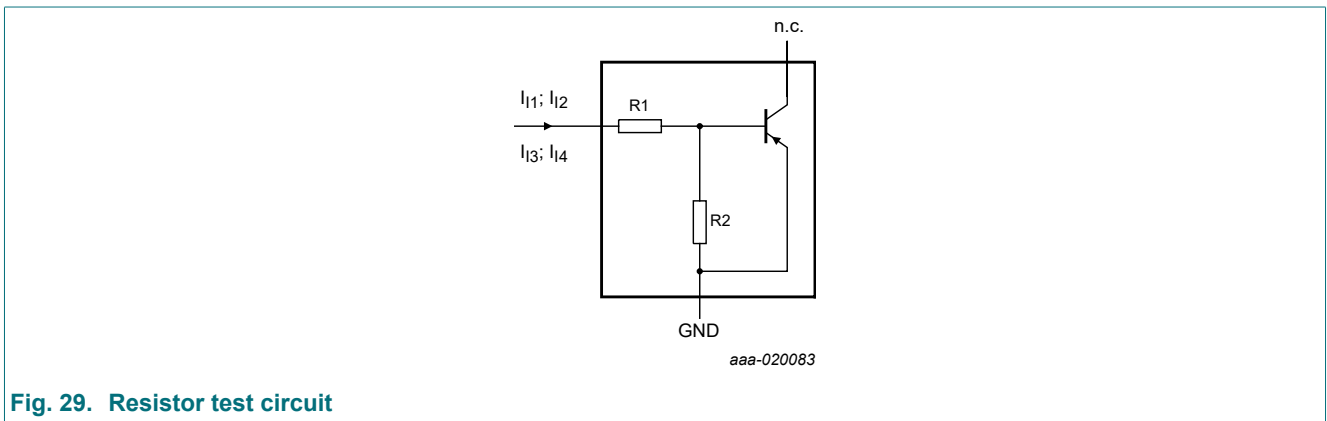


Fig. 29. Resistor test circuit

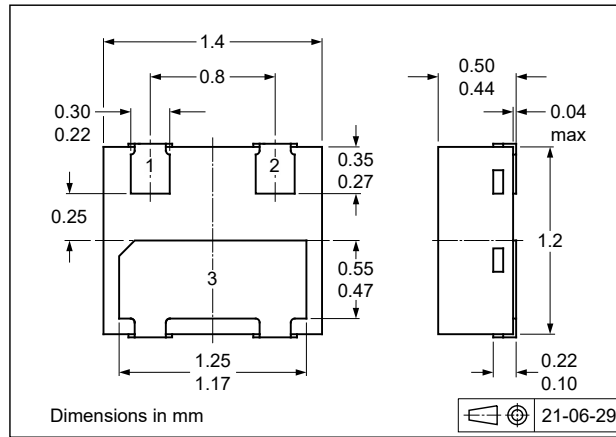


Fig. 30. Package outline DFN1412D-3 (SOT8009)

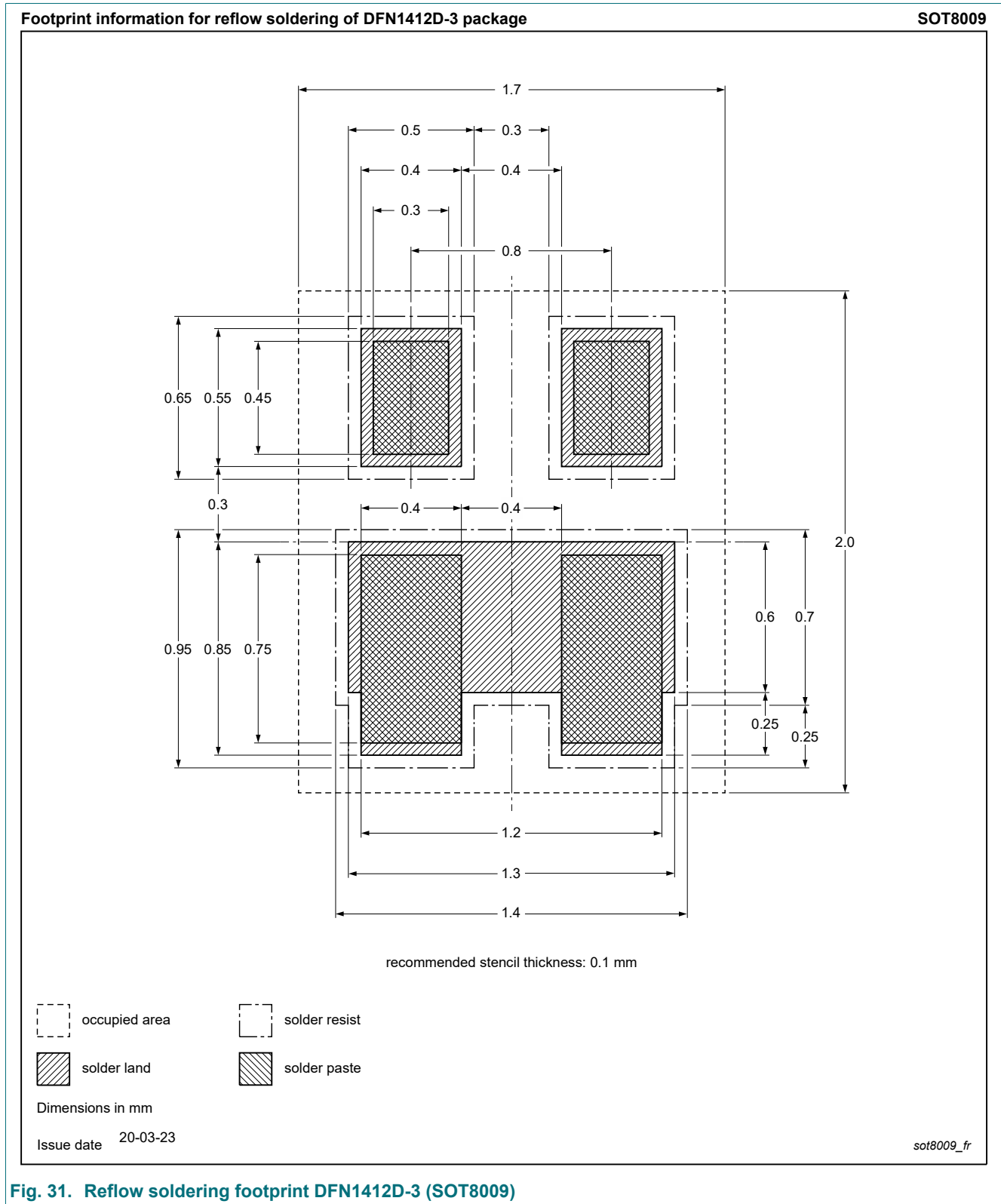


Fig. 31. Reflow soldering footprint DFN1412D-3 (SOT8009)
