


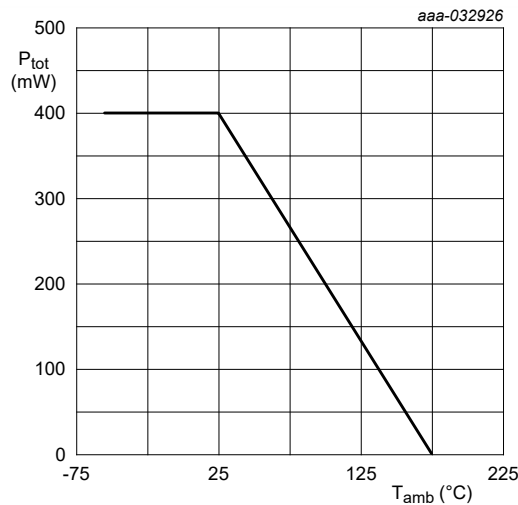

FR4 PCB, single-sided, 35  $\mu$ m copper, tin-plated and standard footprint

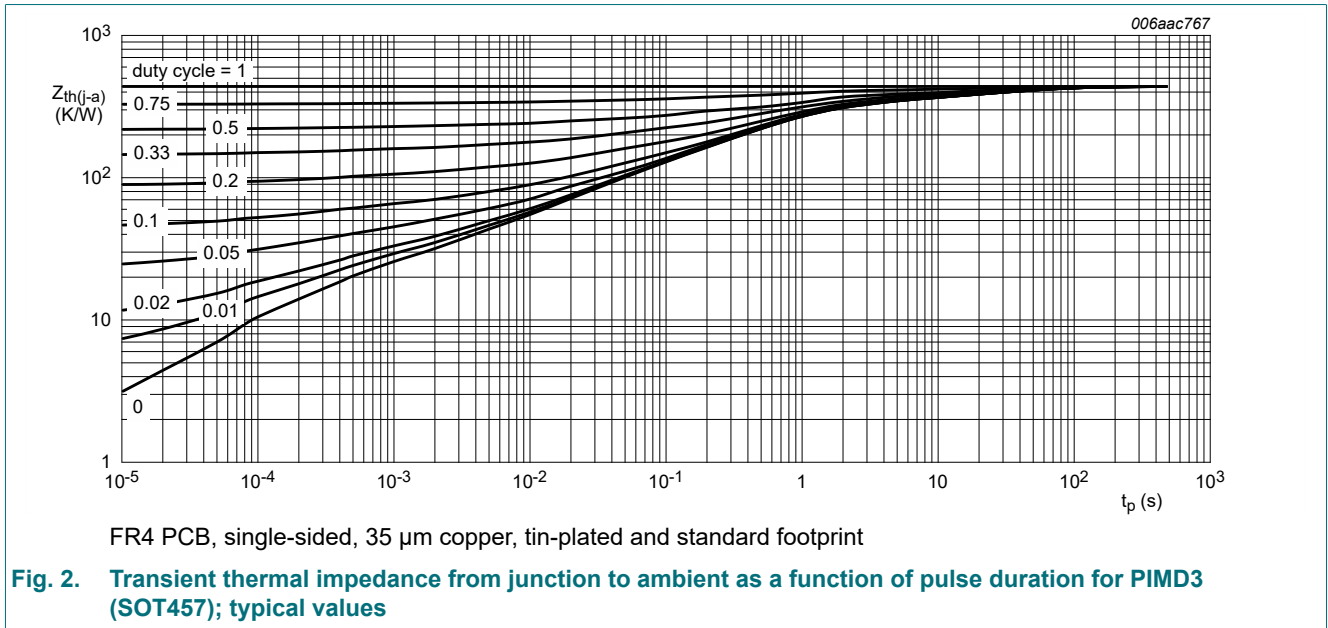
**Fig. 1. Per device: Power derating curve**

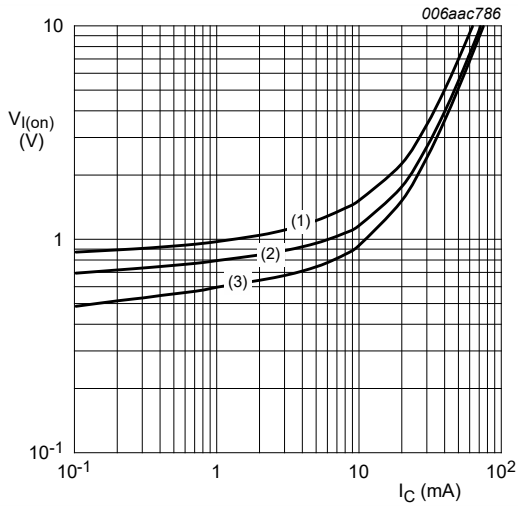

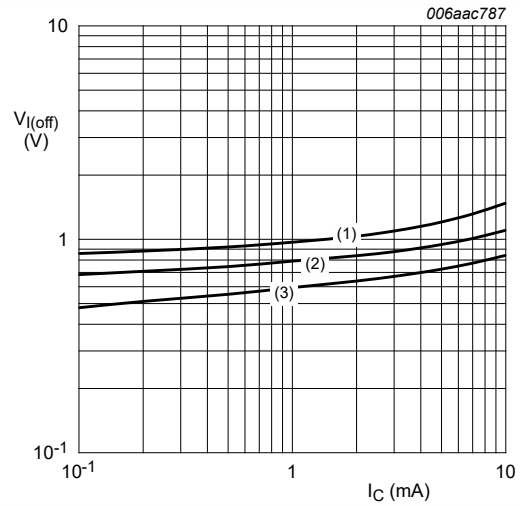

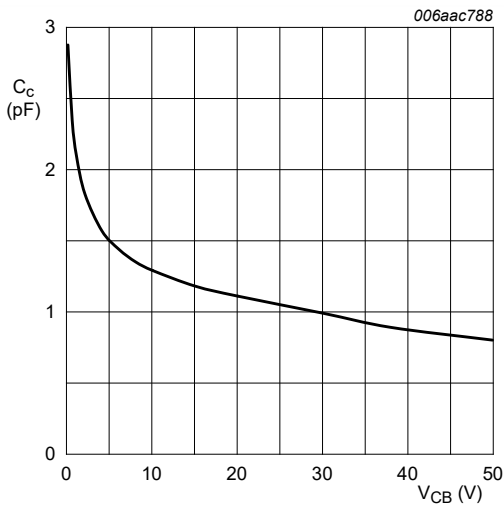

**Fig. 5. On-state input voltage as a function of collector current; typical values**



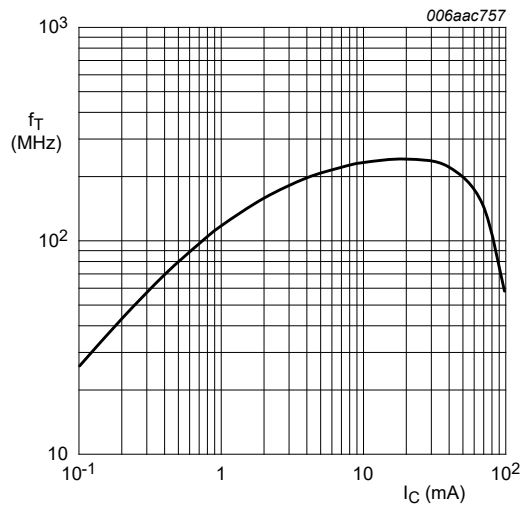

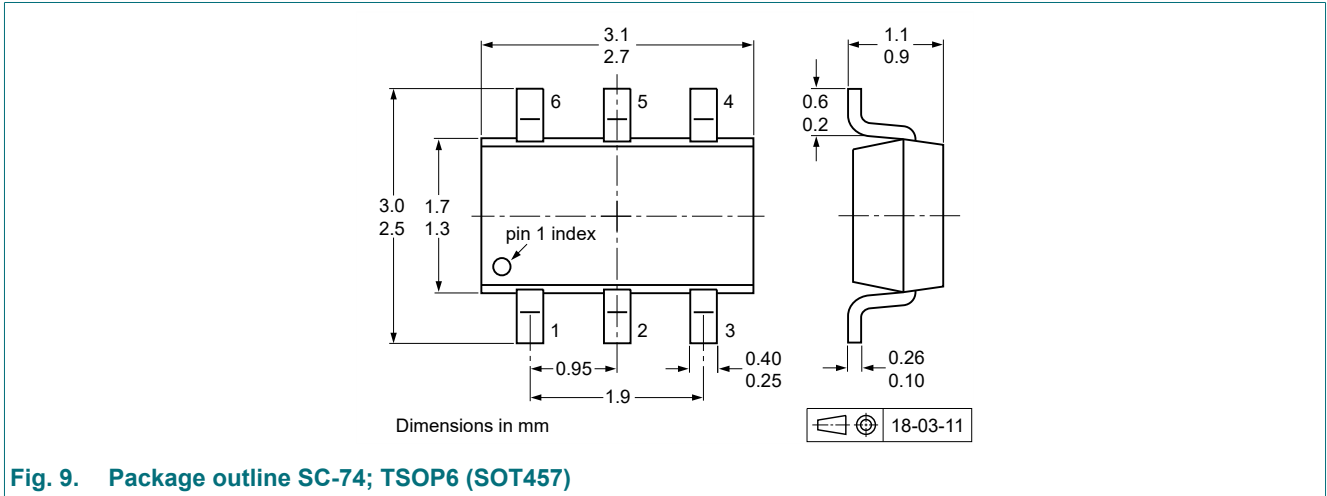


Fig. 9. Package outline SC-74; TSOP6 (SOT457)

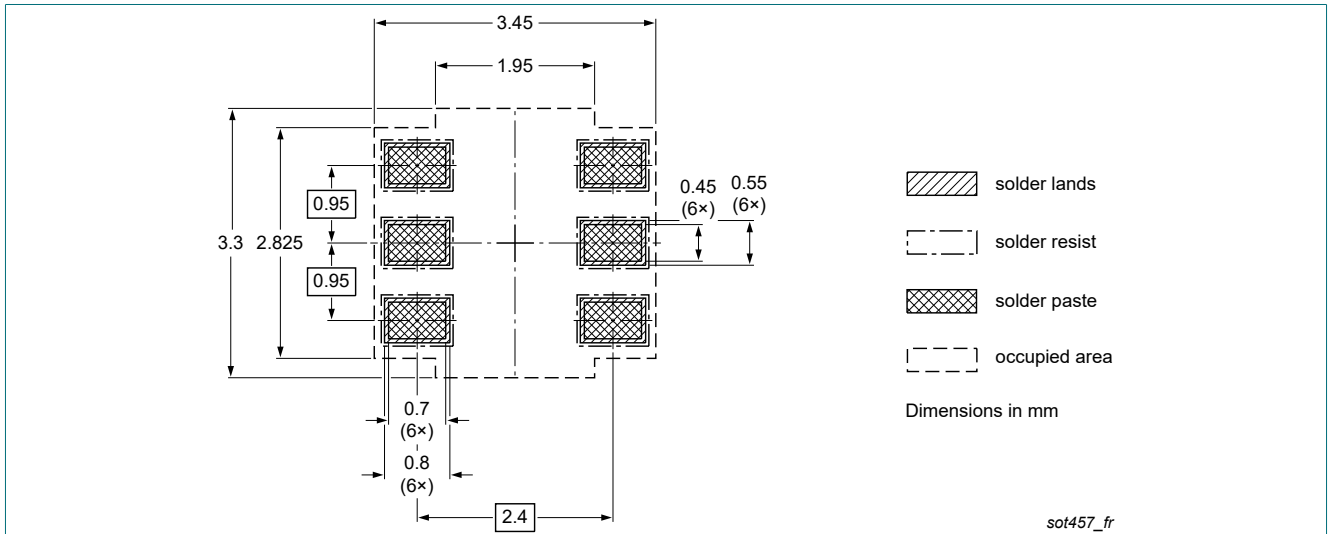


Fig. 10. Reflow soldering footprint for SC-74; TSOP6 (SOT457)

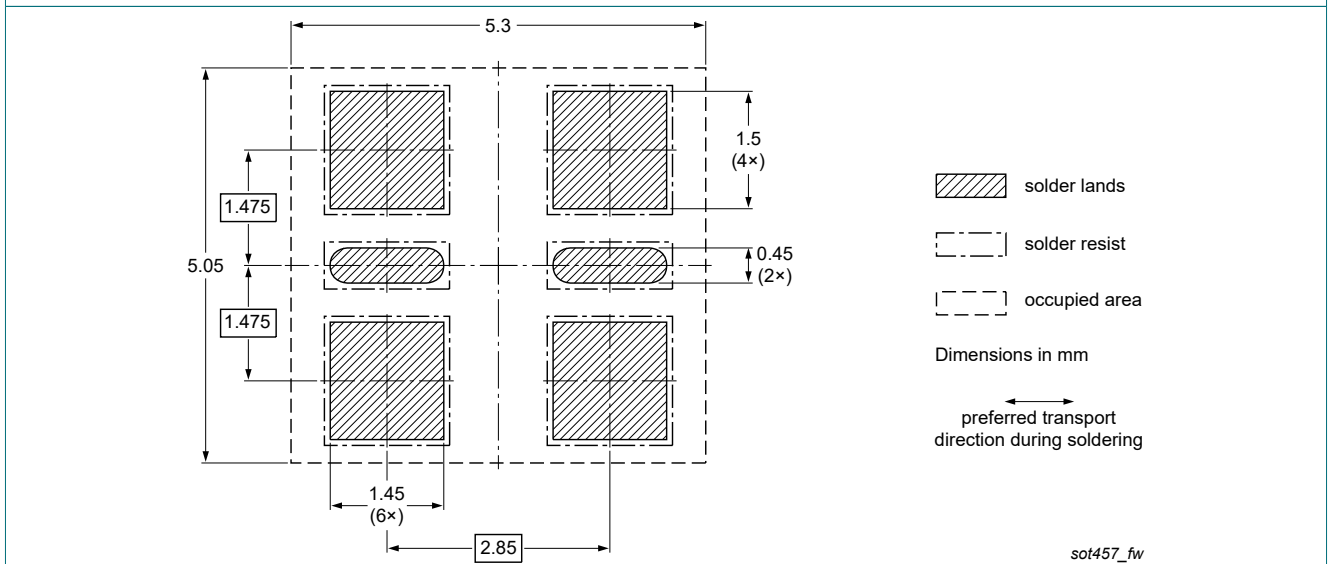


Fig. 11. Wave soldering footprint for SC-74; TSOP6 (SOT457)
