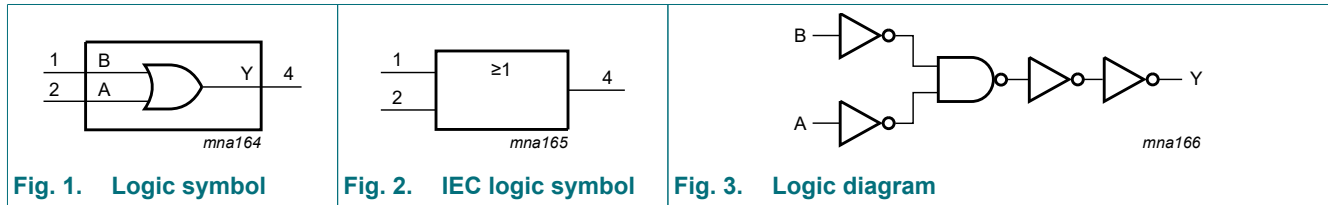

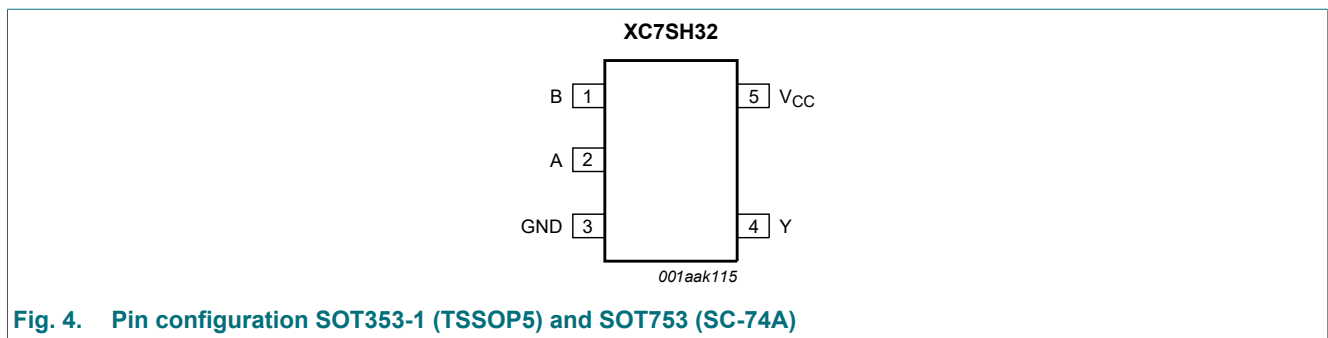

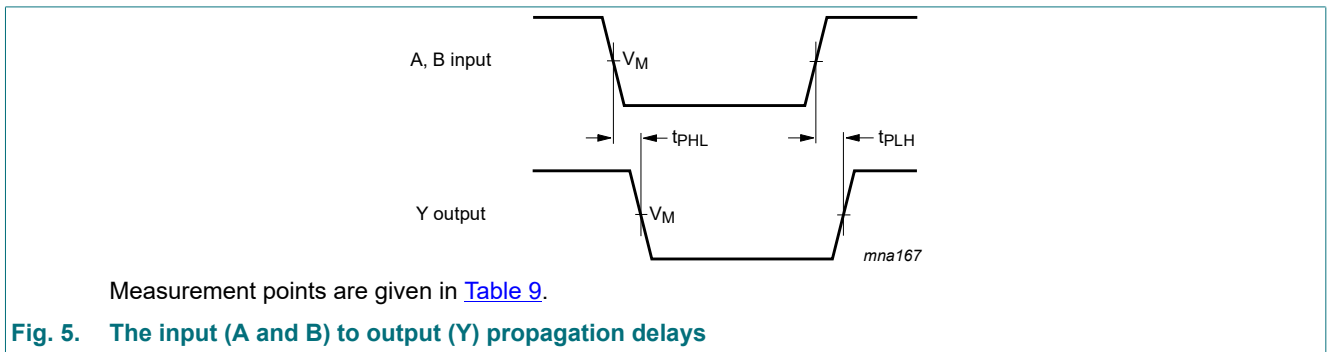
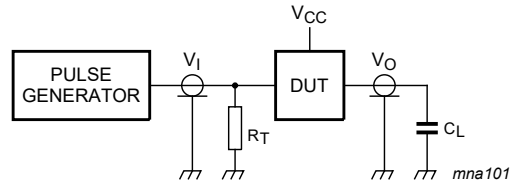


Fig. 5. The input (A and B) to output (Y) propagation delays

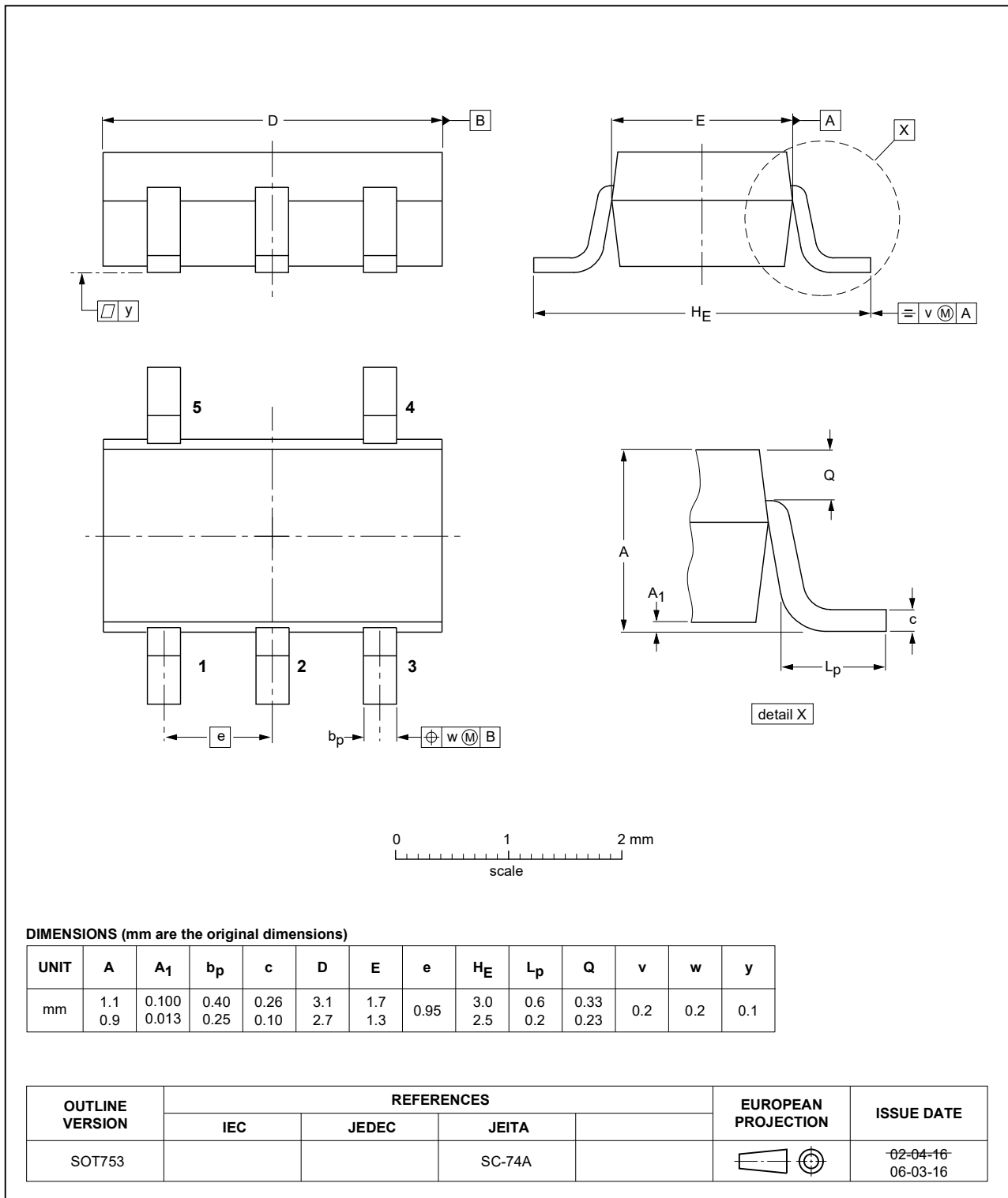


Fig. 8. Package outline SOT753 (SC-74A)
