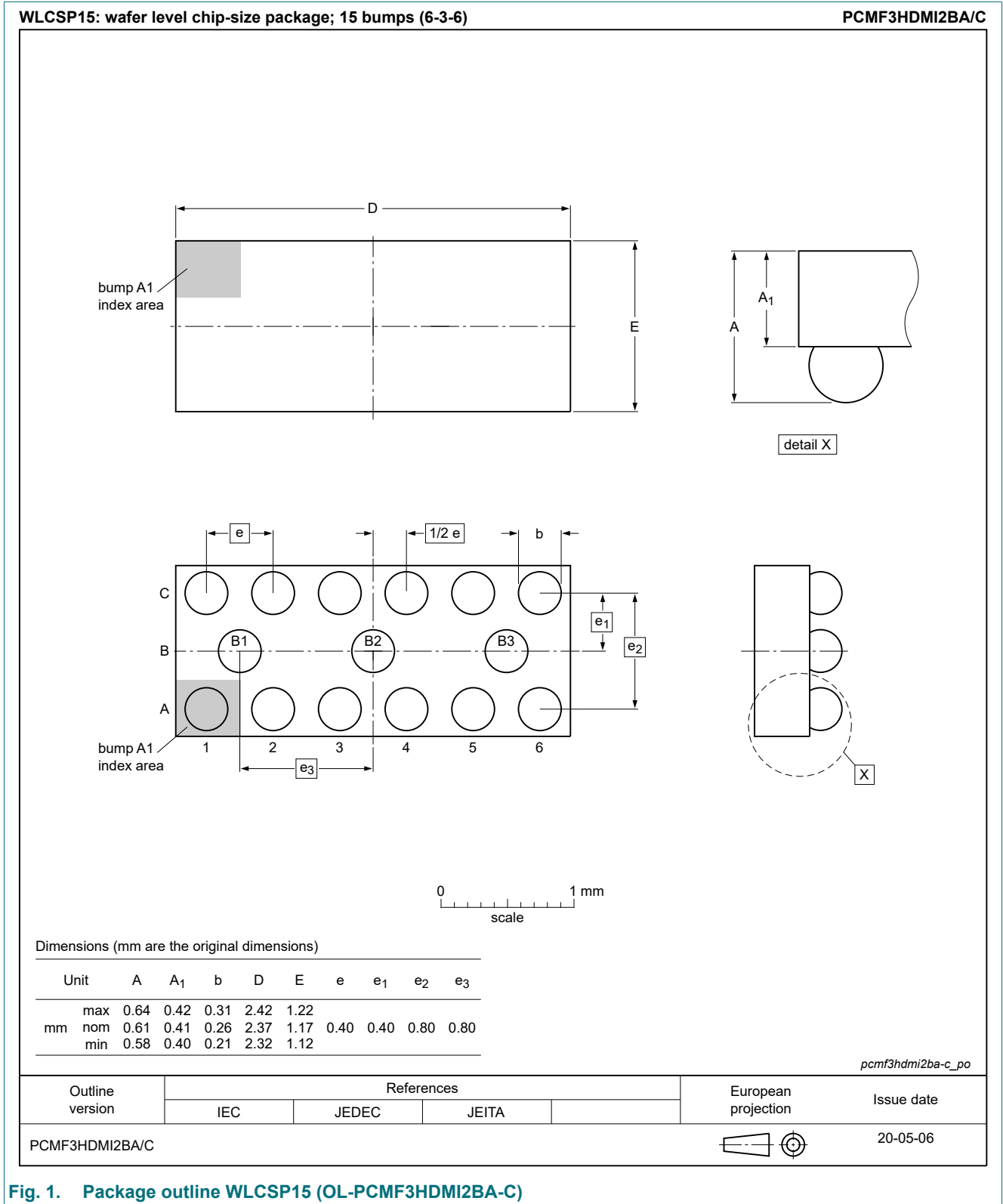


Fig. 1. Package outline WLCSP15 (OL-PCMF3HDMI2BA-C)

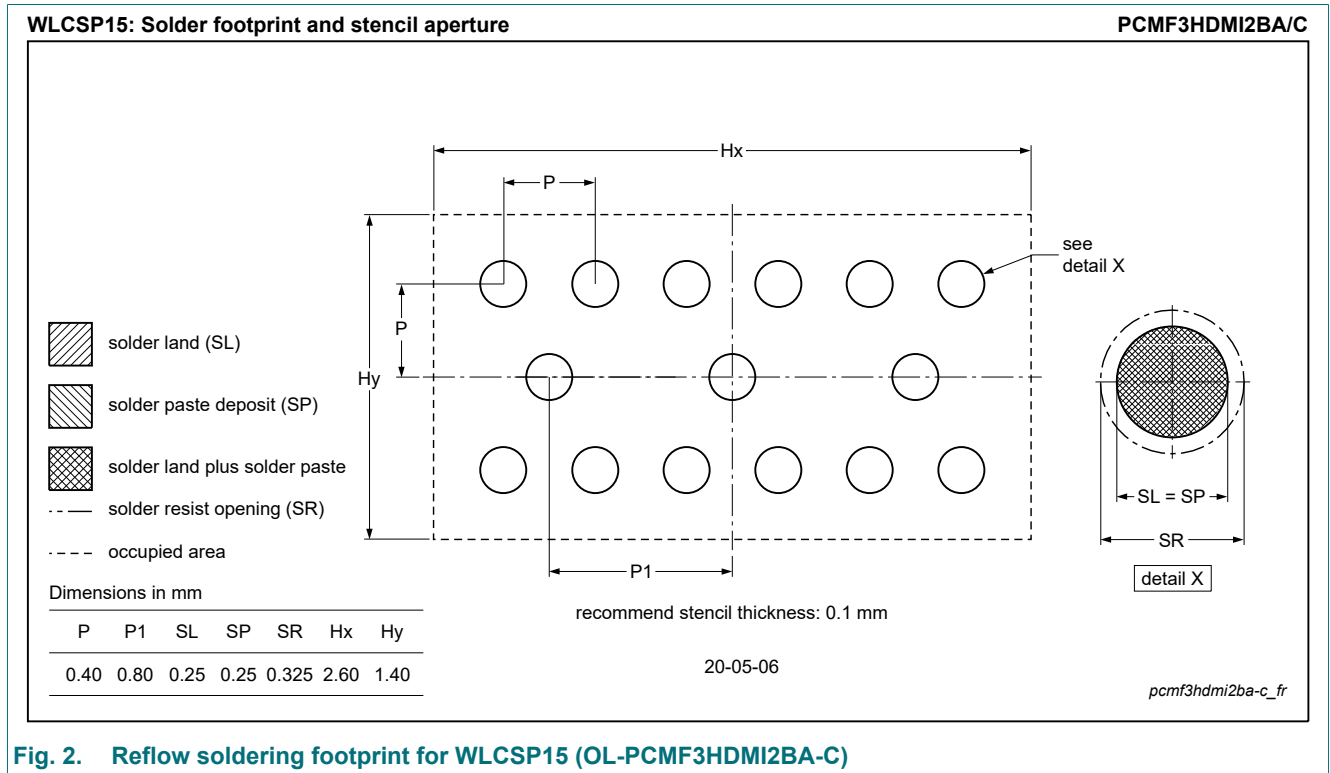


Fig. 2. Reflow soldering footprint for WLCSP15 (OL-PCMF3HDMI2BA-C)
