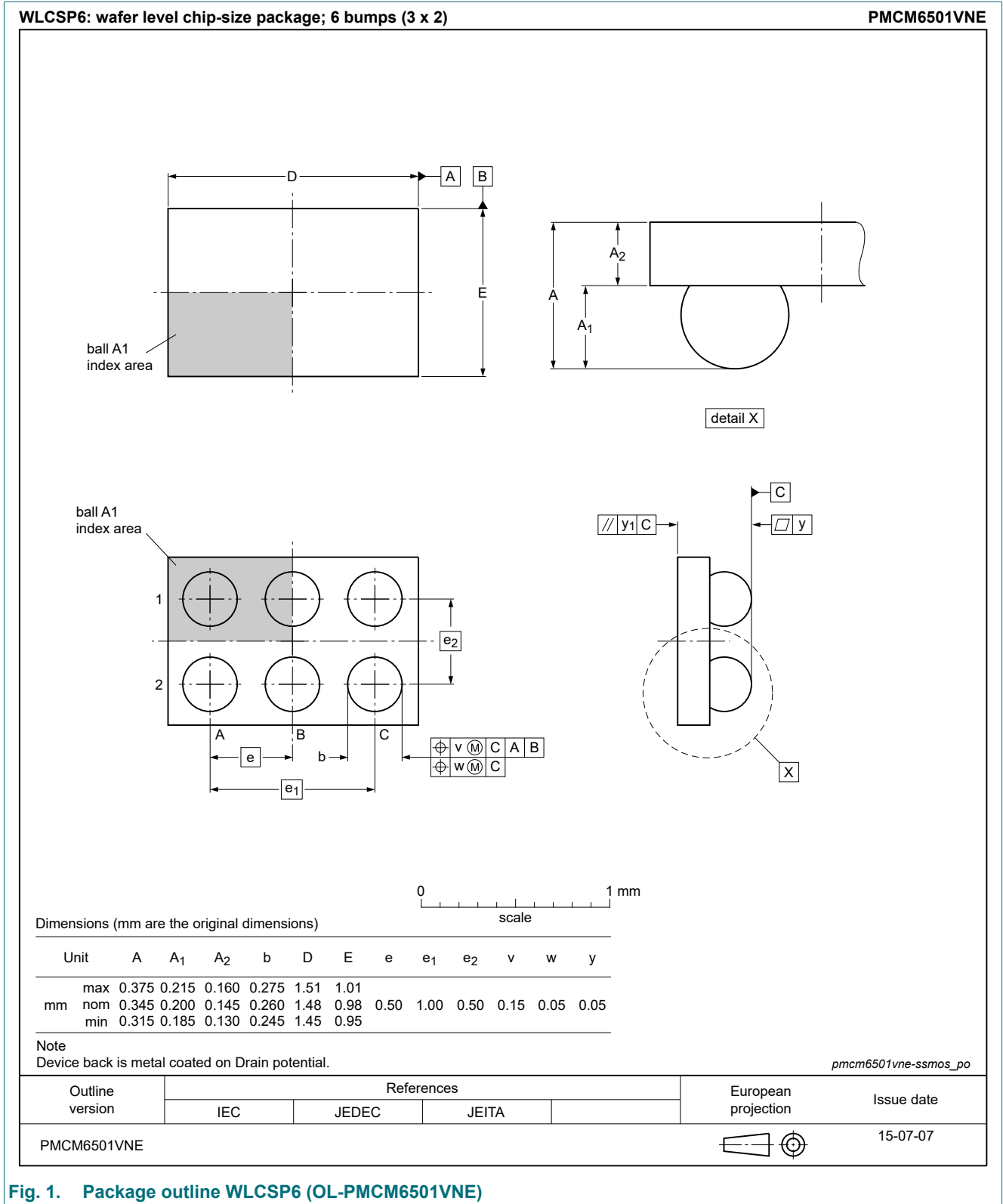


Fig. 1. Package outline WLCSP6 (OL-PMCM6501VNE)

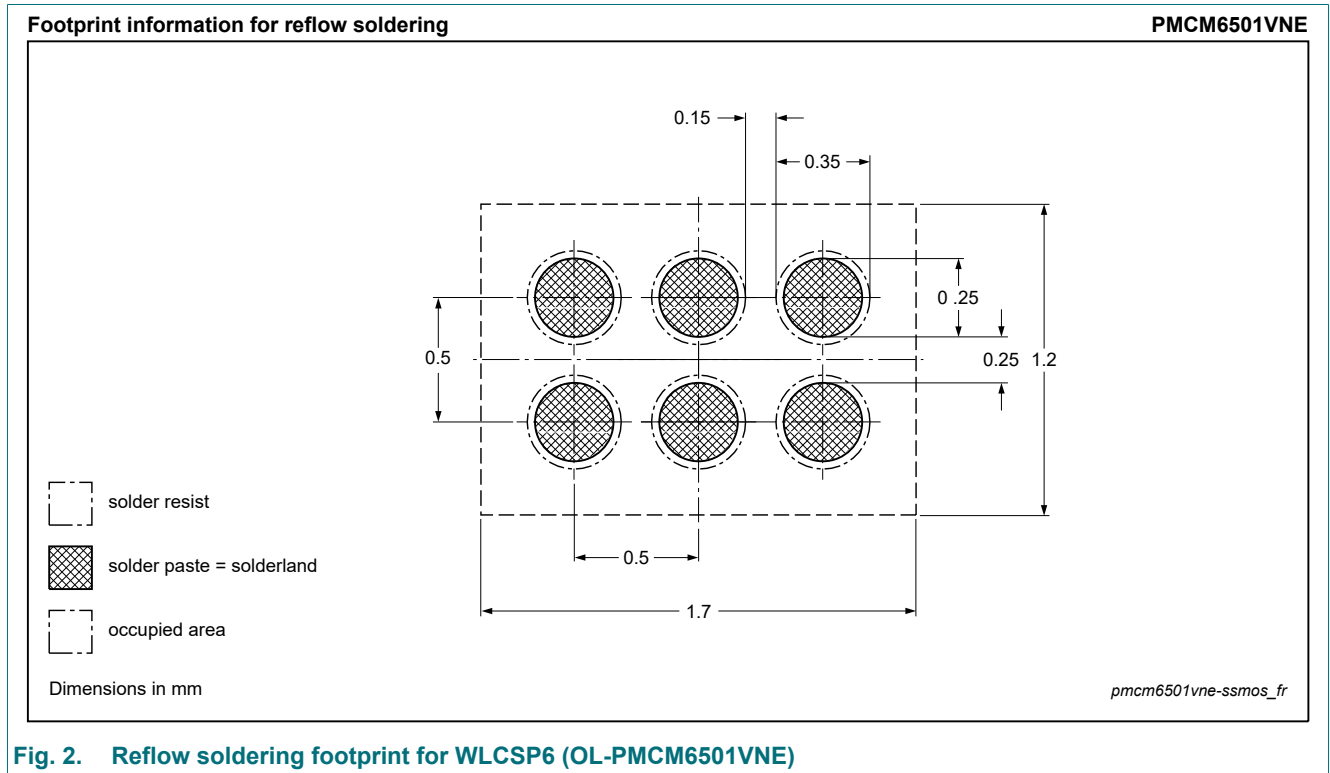


Fig. 2. Reflow soldering footprint for WLCSP6 (OL-PMCM6501VNE)
