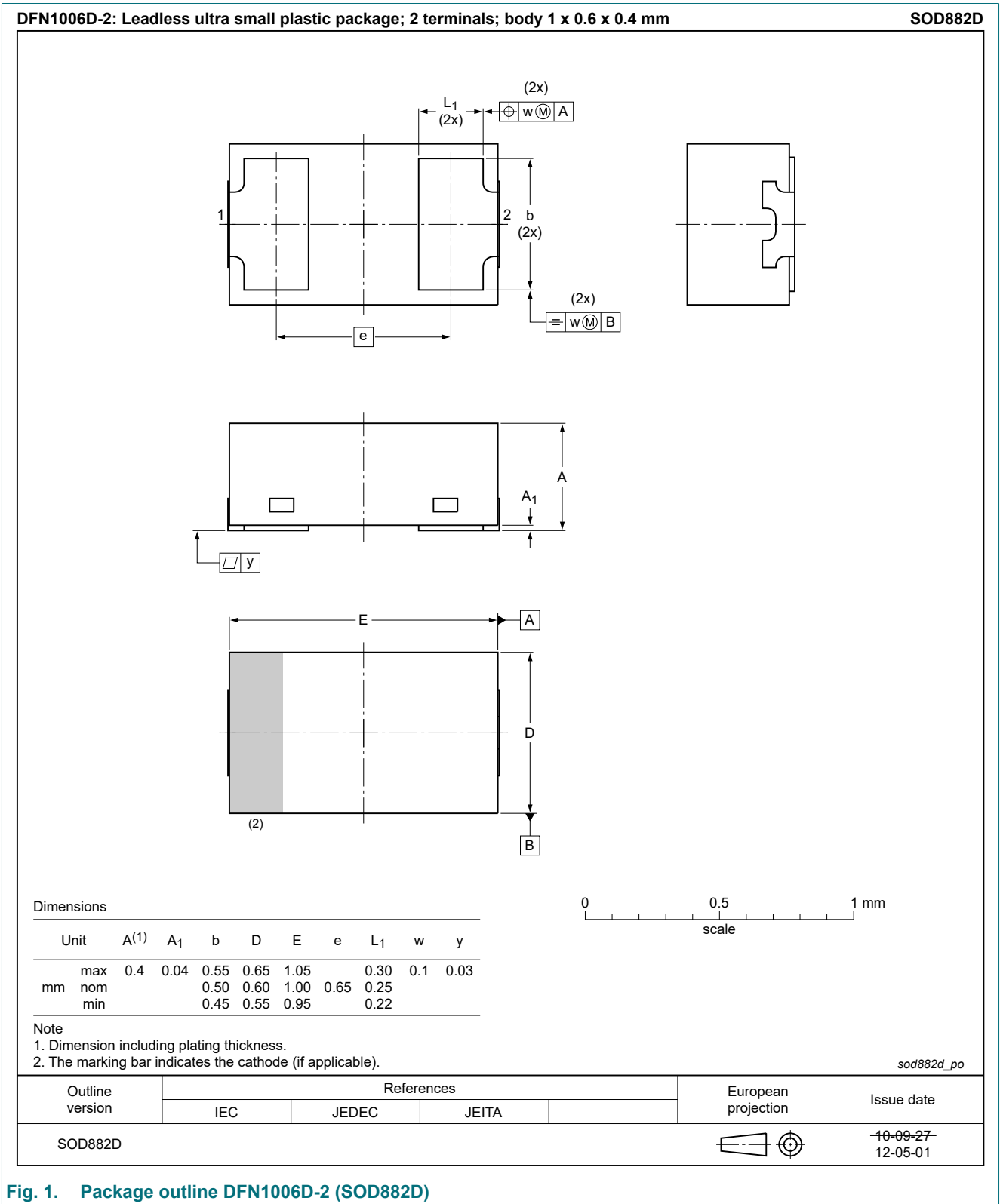


Fig. 1. Package outline DFN1006D-2 (SOD882D)

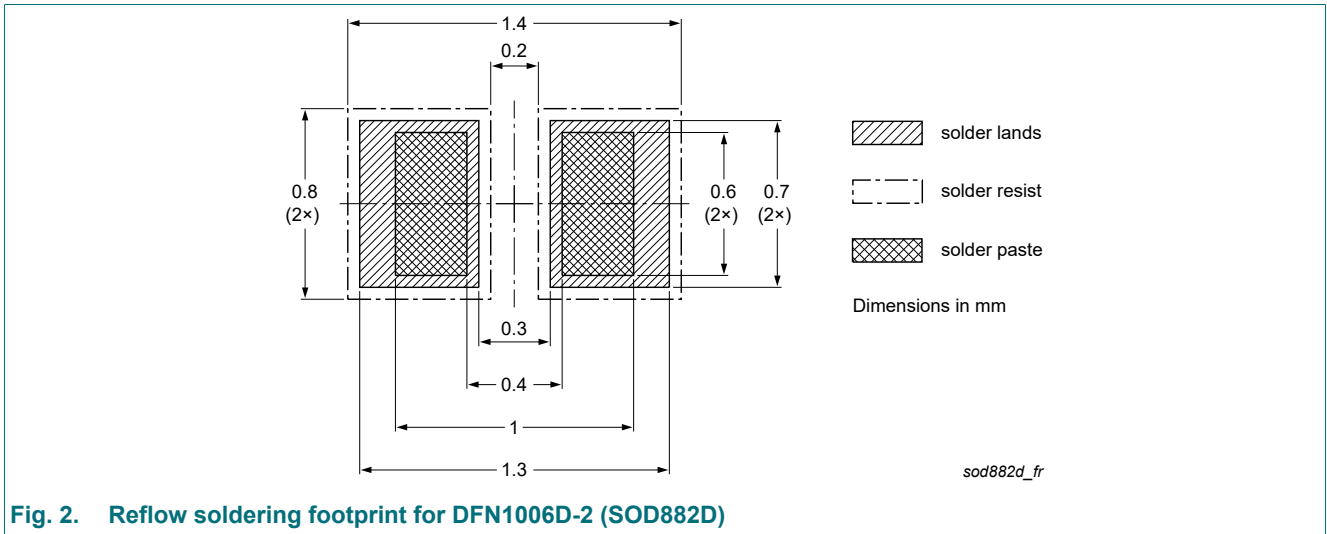


Fig. 2. Reflow soldering footprint for DFN1006D-2 (SOD882D)
