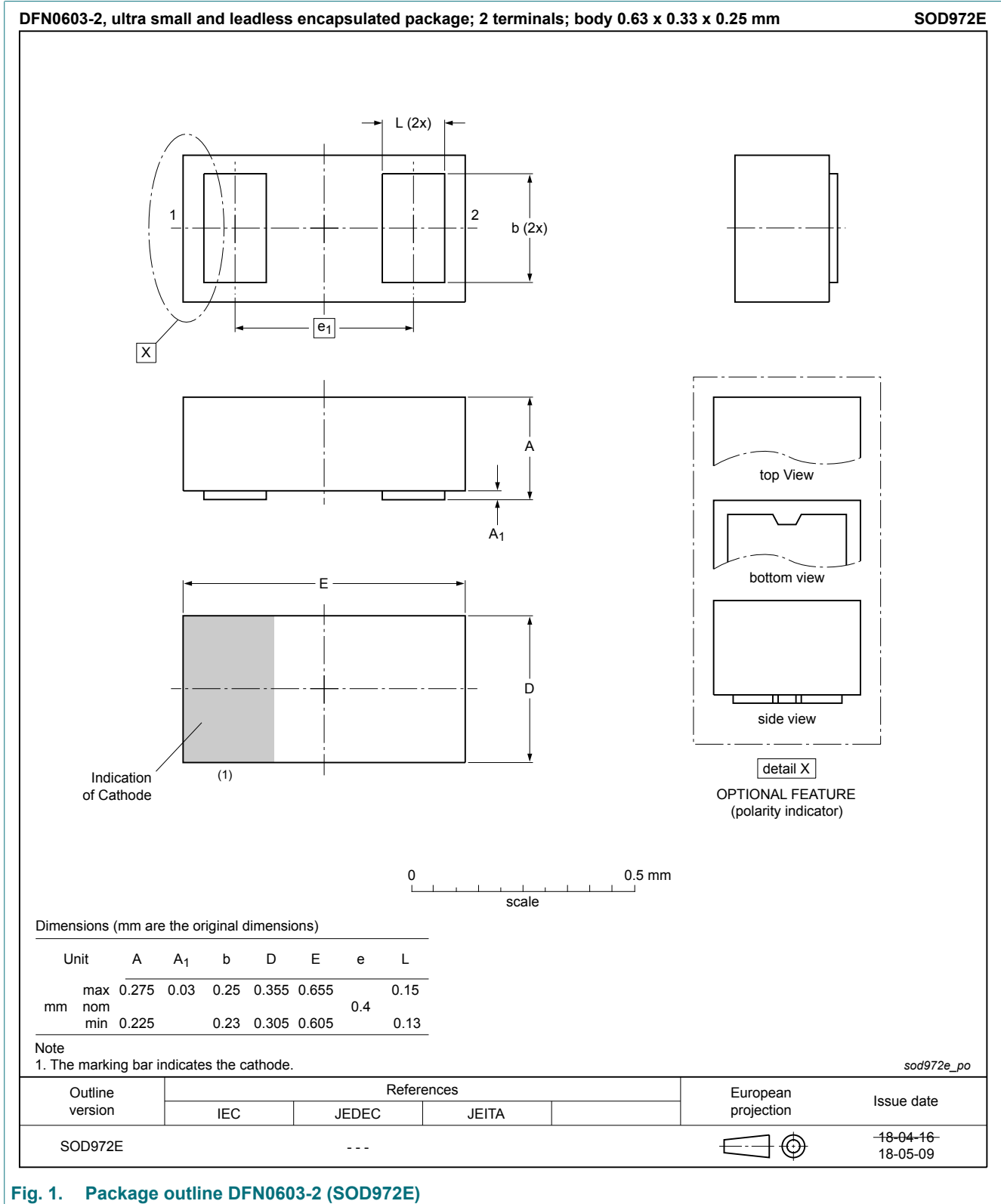
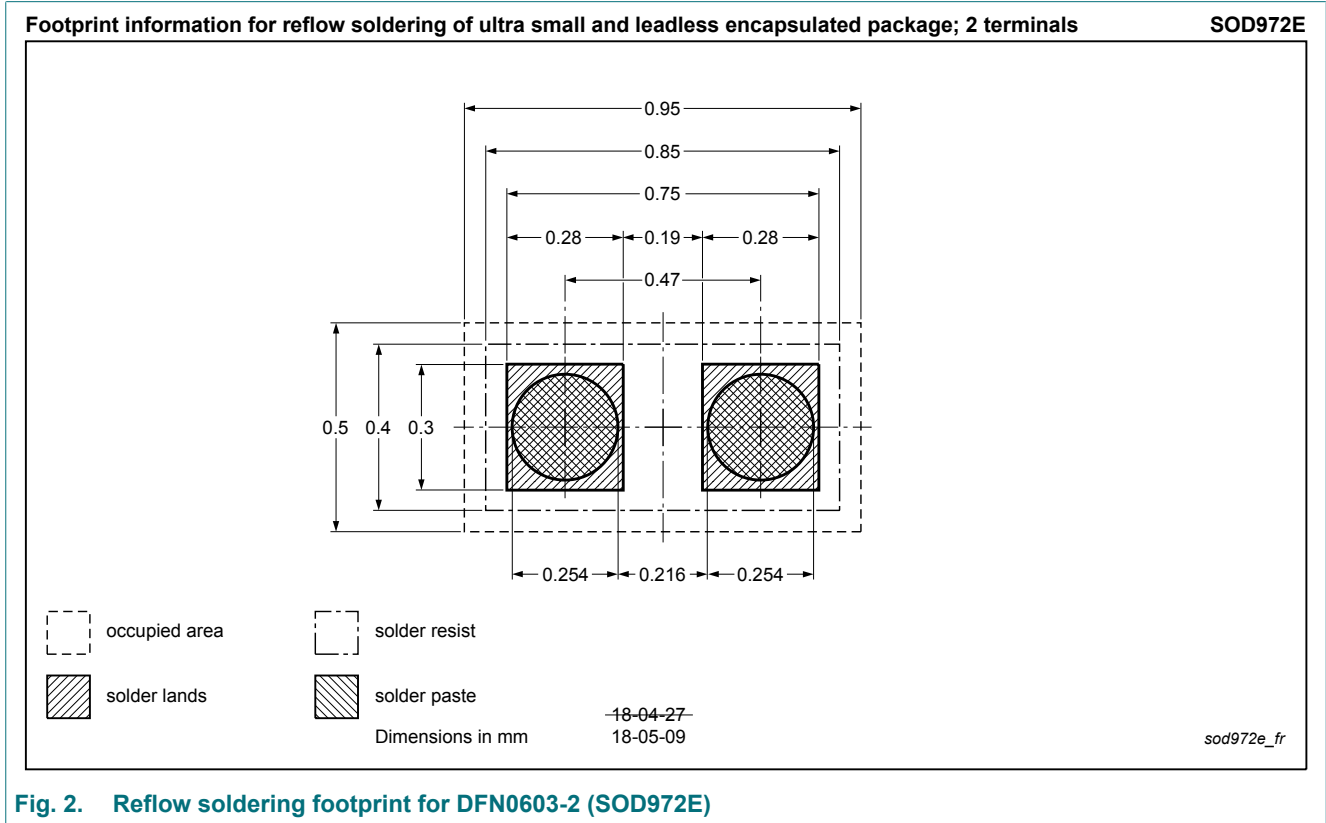


Fig. 1. Package outline DFN0603-2 (SOD972E)
