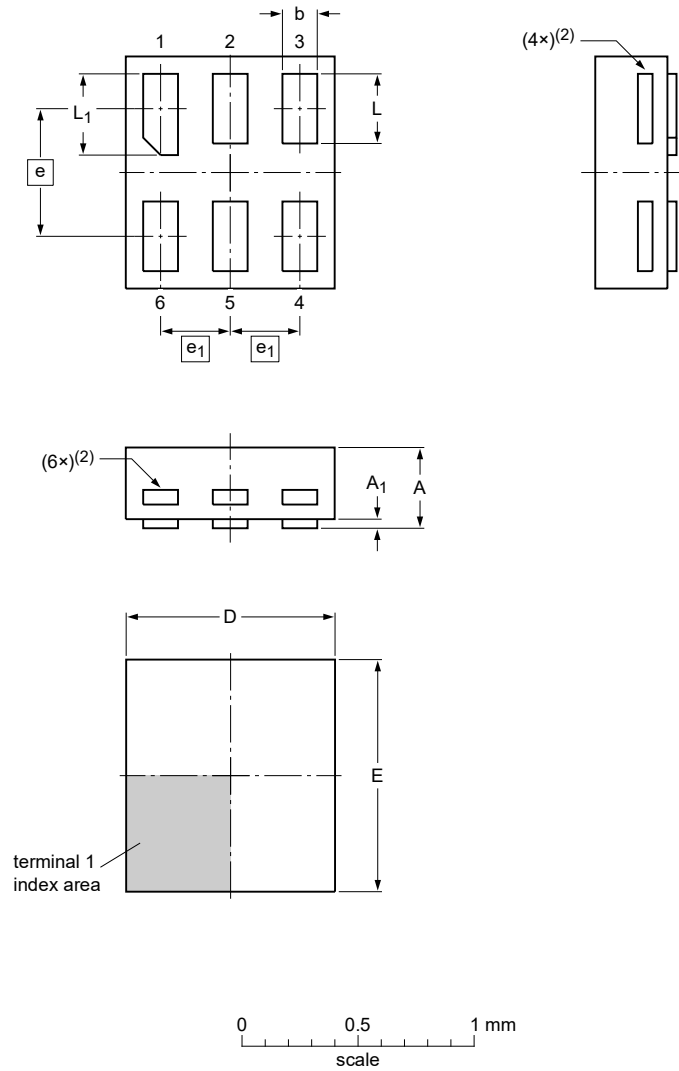

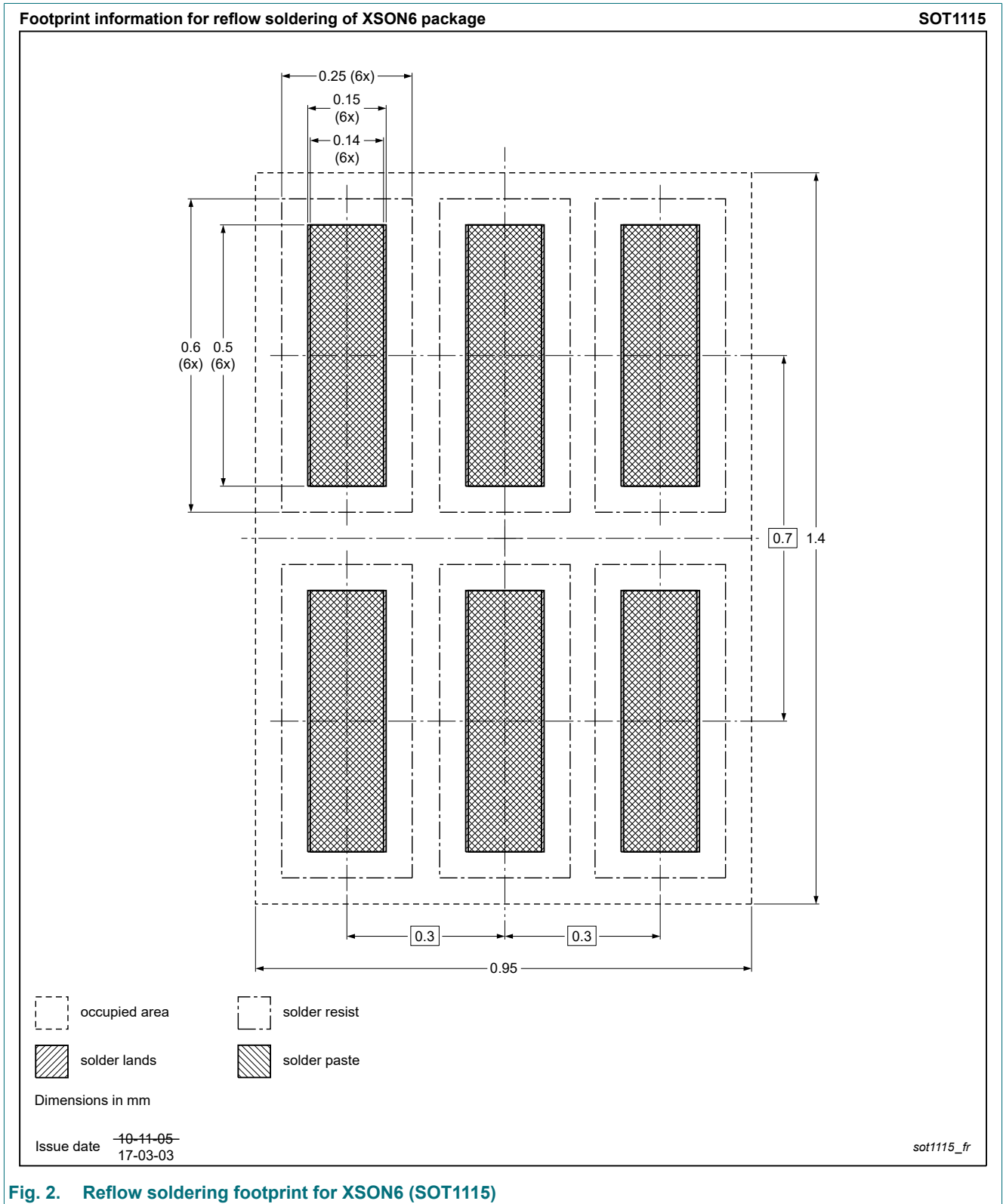


Fig. 2. Reflow soldering footprint for XSON6 (SOT1115)
