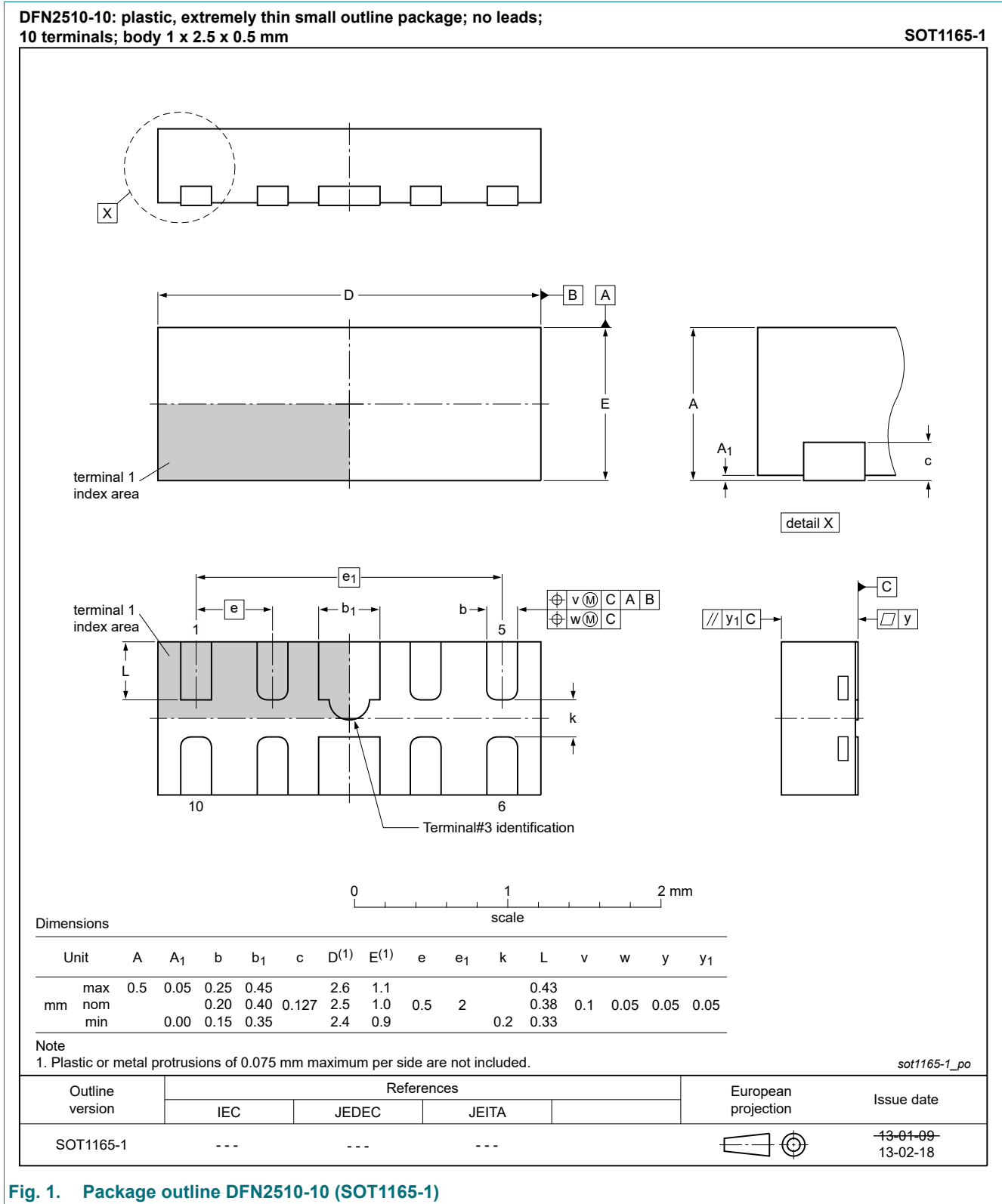


Fig. 1. Package outline DFN2510-10 (SOT1165-1)

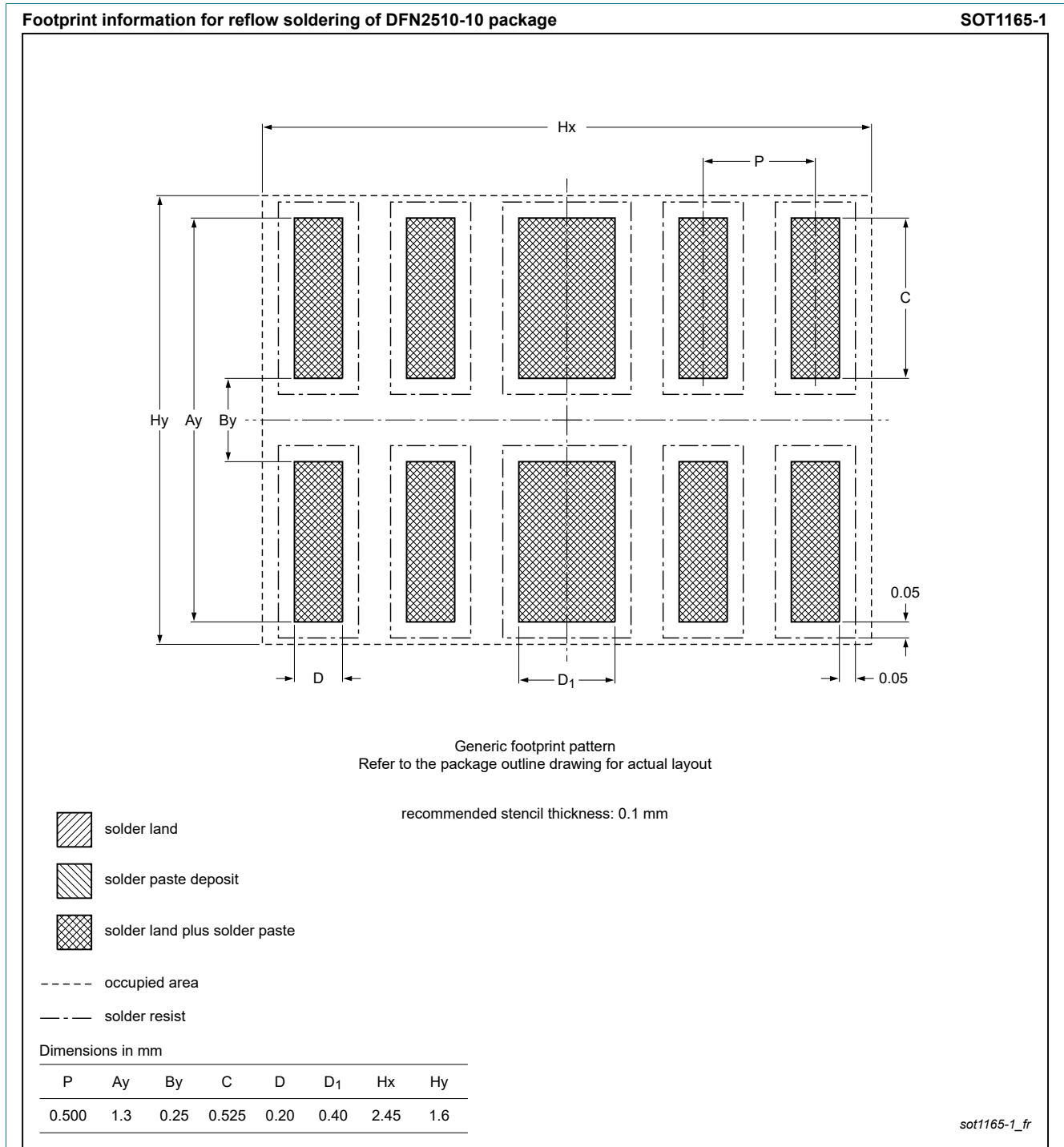


Fig. 2. Reflow soldering footprint for DFN2510-10 (SOT1165-1)
