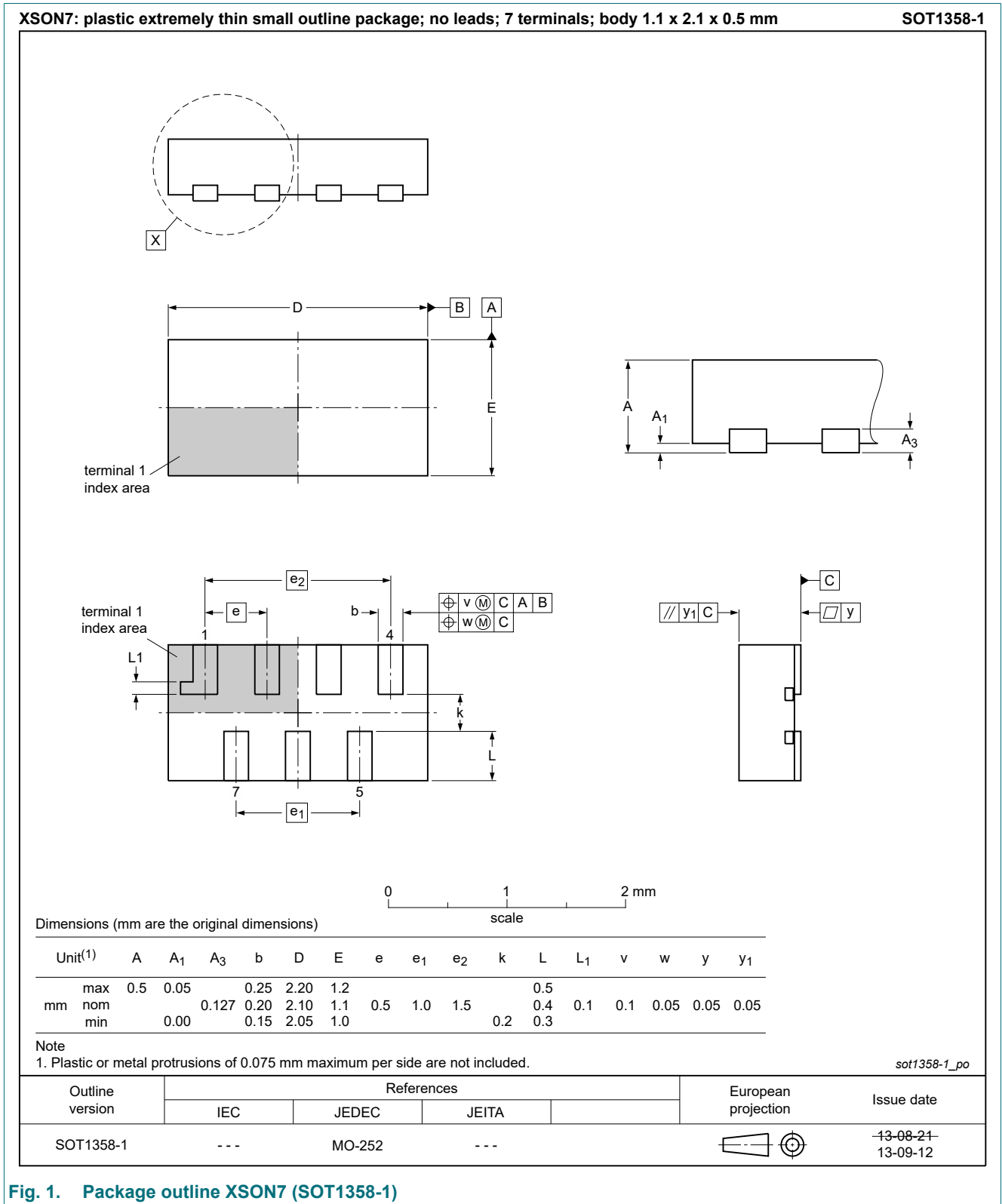


Fig. 1. Package outline XSON7 (SOT1358-1)

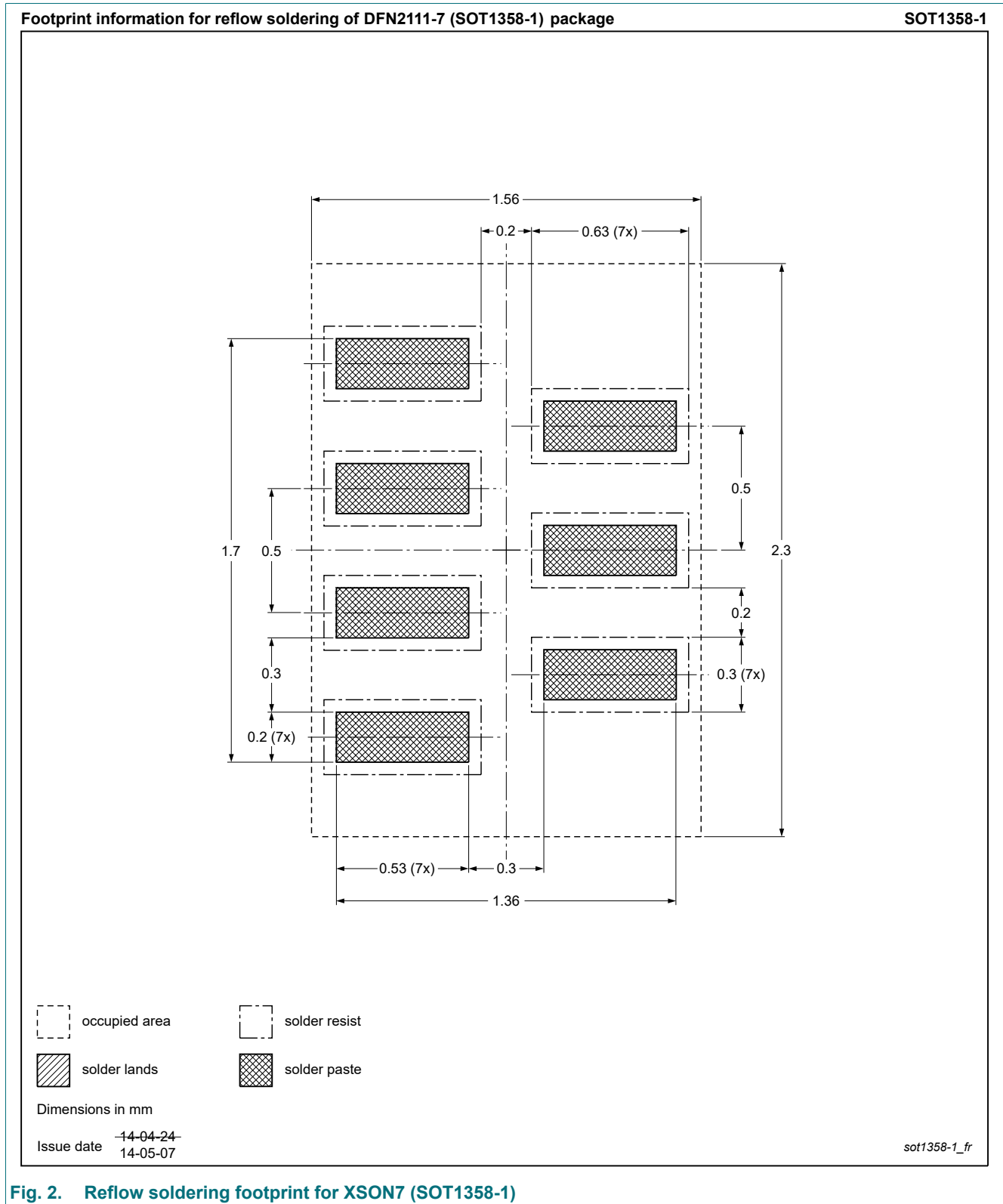


Fig. 2. Reflow soldering footprint for XSON7 (SOT1358-1)
