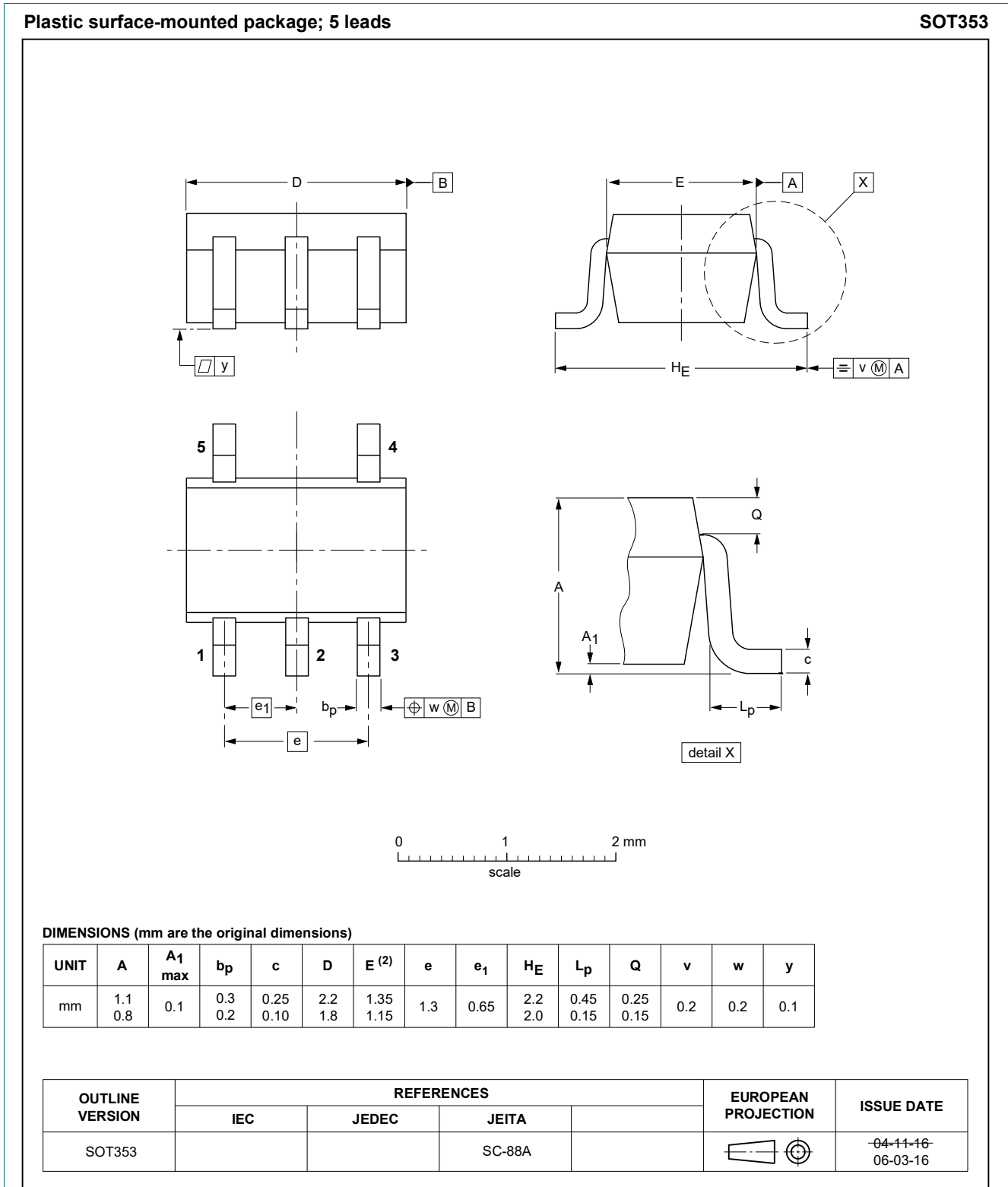


Fig. 1. Package outline TSSOP5 (SOT353)

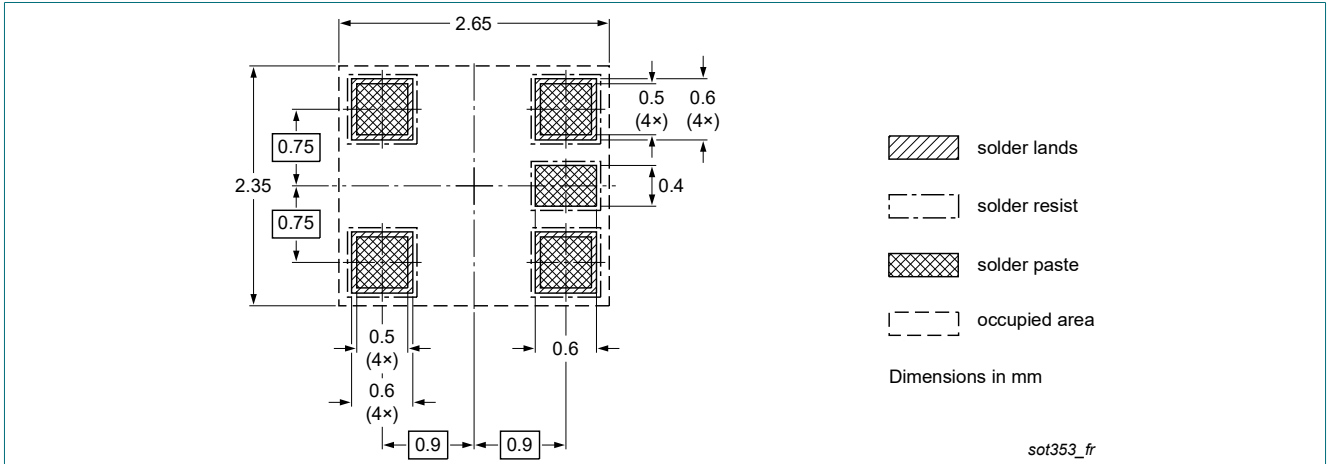


Fig. 2. Reflow soldering footprint for TSSOP5 (SOT353)

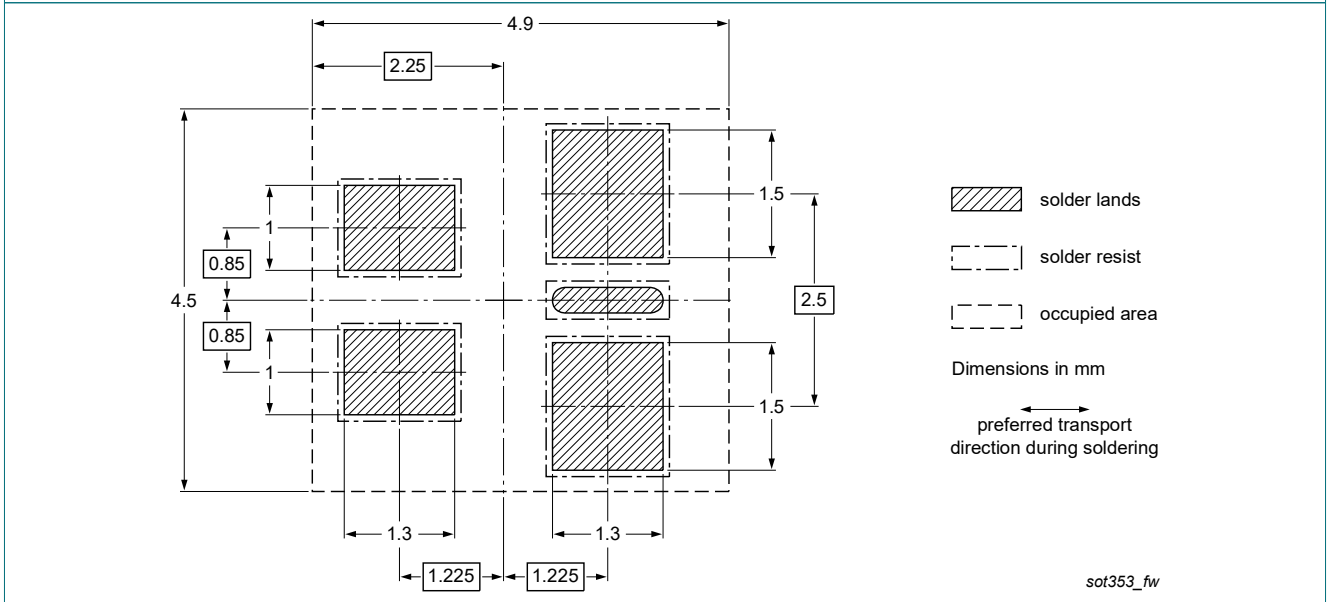


Fig. 3. Wave soldering footprint for TSSOP5 (SOT353)
