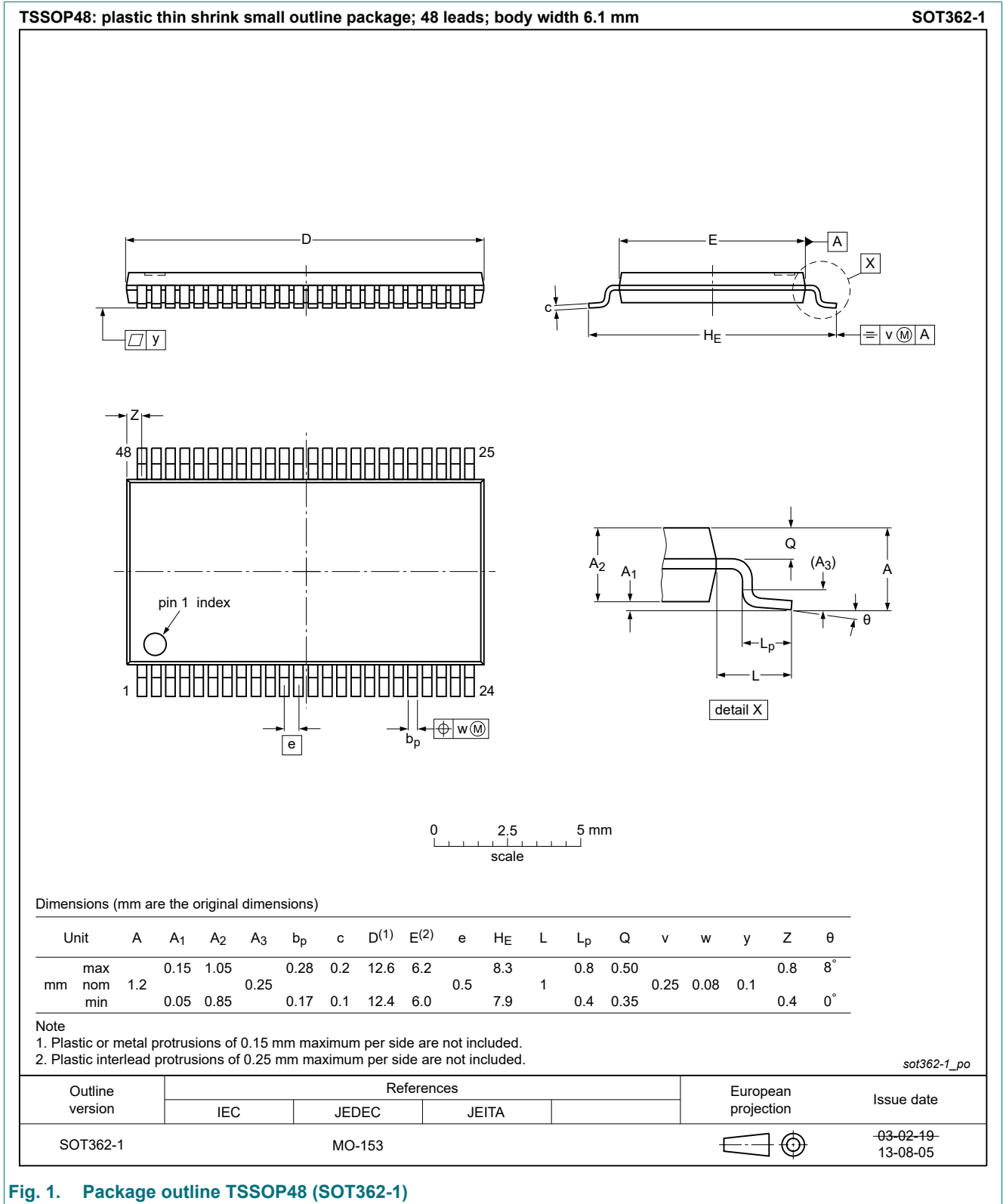


Fig. 1. Package outline TSSOP48 (SOT362-1)

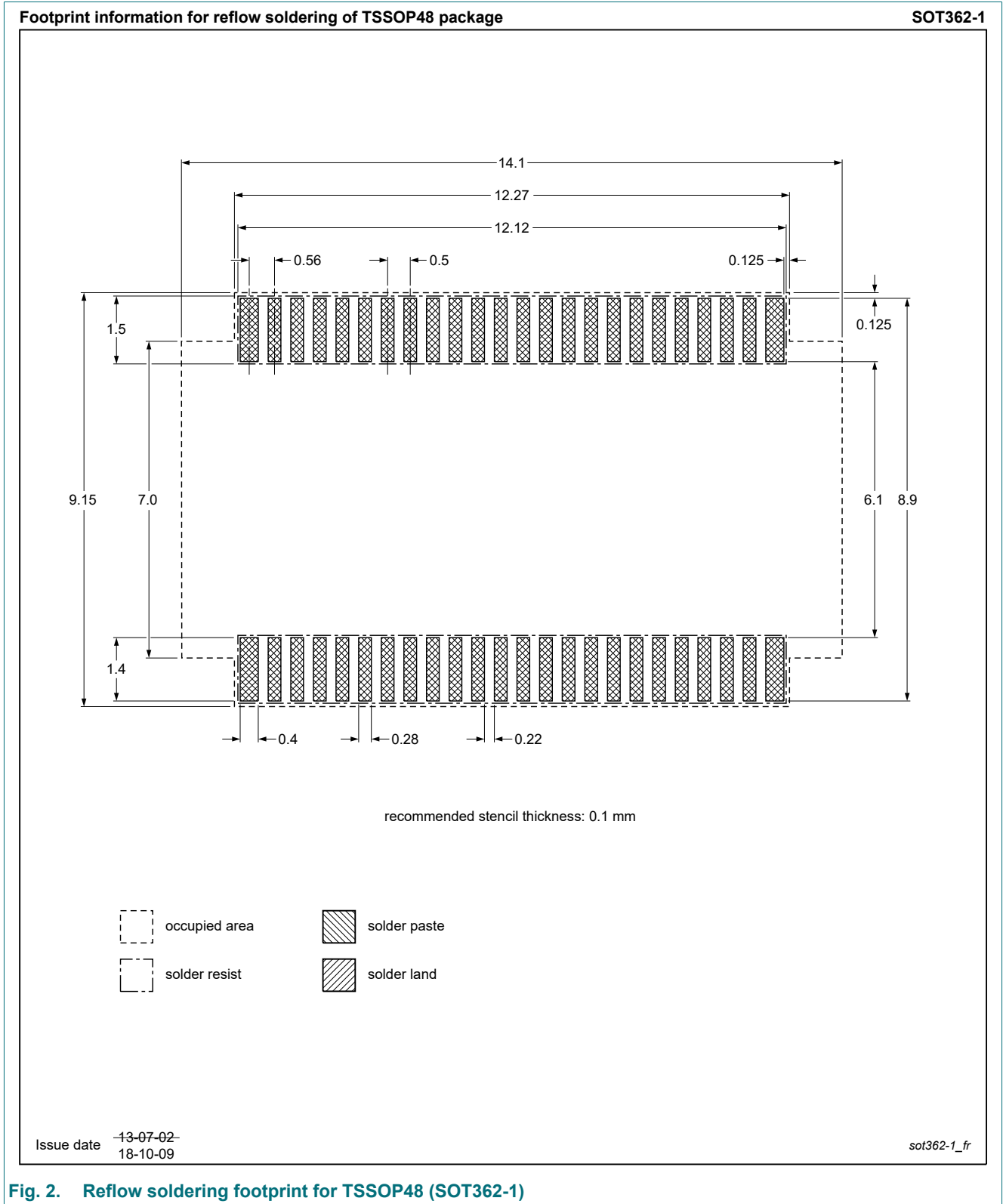


Fig. 2. Reflow soldering footprint for TSSOP48 (SOT362-1)
