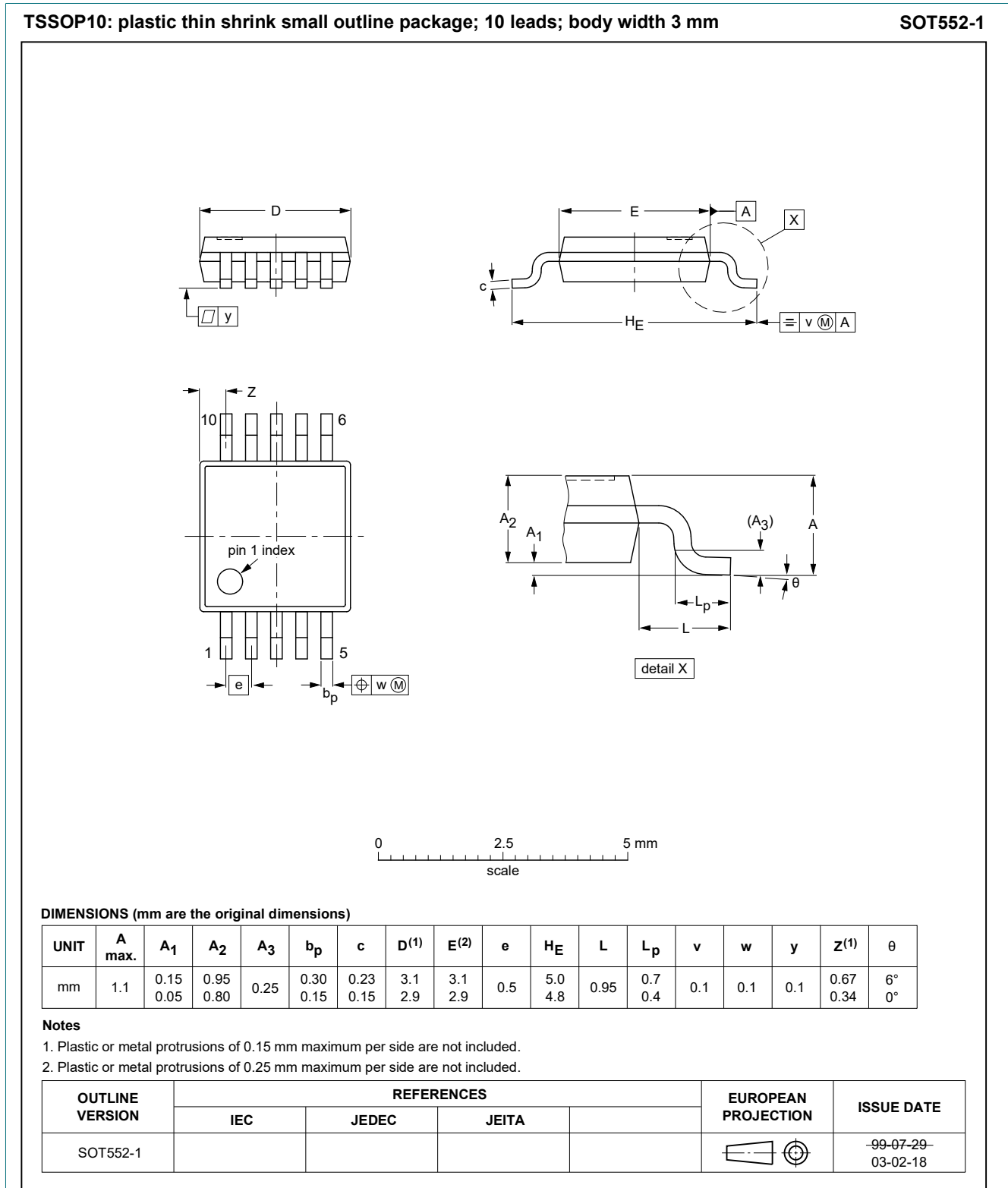


Fig. 1. Package outline TSSOP10 (SOT552-1)

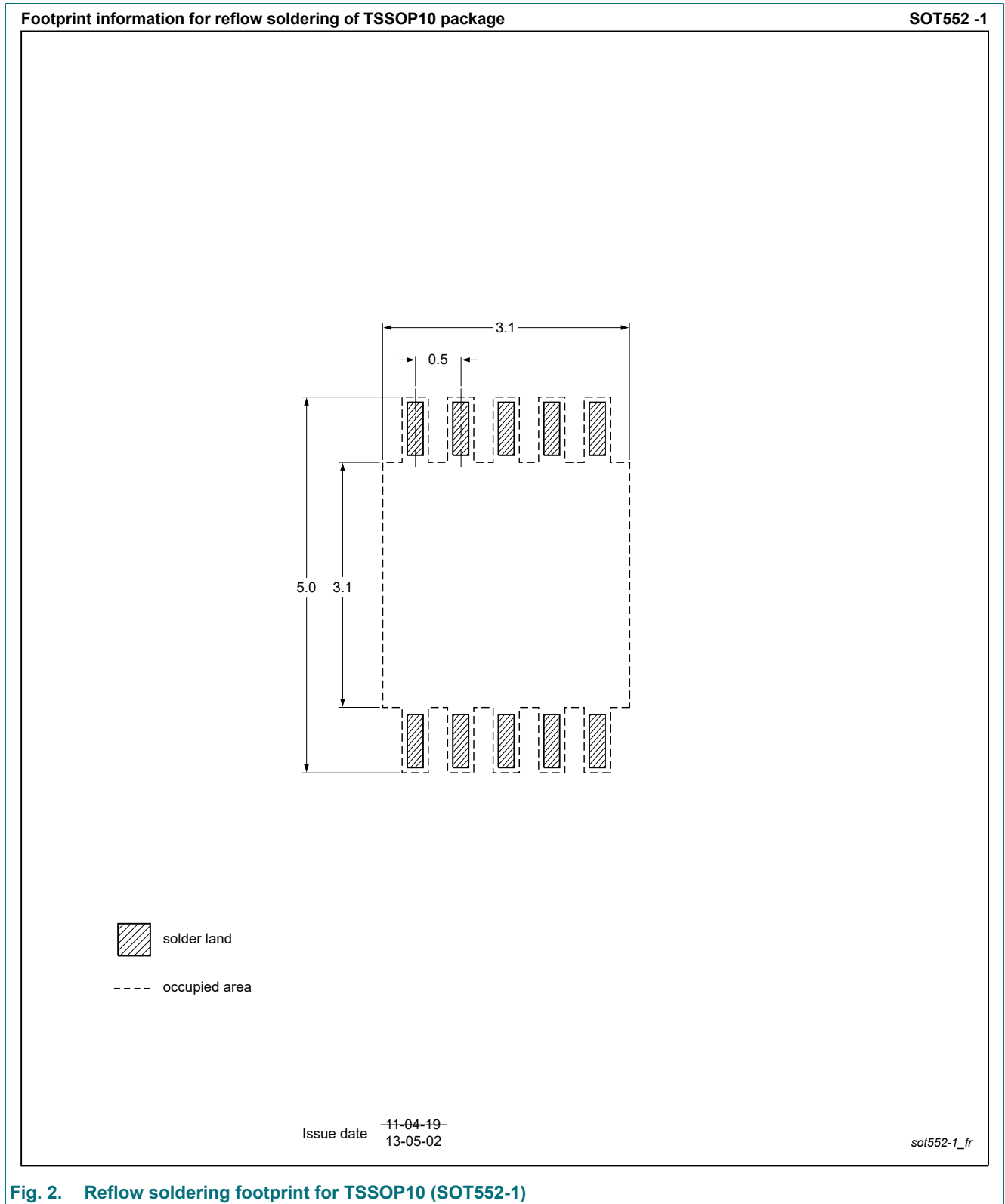


Fig. 2. Reflow soldering footprint for TSSOP10 (SOT552-1)
